EDITORIAL.

X / E follow the time-honoured custom of having nothing to say, -and saying it. A long list of school hours has been negotiated, but we are not vet so bored as the Education Office must be. A good deal has also been done elsewhere. The Football Team is decidedly above the average; it has shown itself quite a class above the School Elevens it has met. With more regular practice, a few more and better chosen matches and more permanence in its composition it would be a most efficient fighting machine, and might easily

neutralise by combination the advantage in weight shown by some of its opponents. There is some very promising material in the second eleven and lower strata.

The gymnasium is already popular; under the direction of Mr. Wright we are developing those muscles which otherwise would waste their suetness on the desert-air, not being employed in so-called games or the avocations of practical life.

Lord Roberts is asking the public Schools of the country to establish a system of national defence, based on the principle that every schoolboy should be instructed in physical training and rifle-shooting. The "Empire Review" for November, containing an article on this appeal, has been sent to us. The opinions of various Head Masters are given. The miniature rifle-range is suggested as solving many difficulties,

while the Warden of Bradfield deprecates the "militarism" which is so apt to infect school "armies"; they should be "citizen" armies. We agree, and note a close connection between red trousers and red-tape; and may remind our readers of Walter Emanuel's definition of soldiers—"Soldiers are men dressed up. Some of these are very Nothing is said about physical training; this is a pity, for the traditional "drill" is quite useless for any purpose whatever, as the Boers and the Japanese have shown us. Something more scientific must take its place; to alter its superficial appearance and label it "physical training" will not deceive the school-boy, though it may hoodwink the rate-payer.

Several students of Hellenic culture saw "The Wasps" at Radley, and much appreciated the Greek humour and the English acting.

On November 10th, Mr. Stafford Webber gave us a most delightful lecture on "Punch." The School Room was crowded, many residents of Abingdon being present. The lecturer touched on the literary as well as the pictorial side of "Punch," its pathos as well as its humour. He complimented the limelight man—the pictures were excellent—and criticised somewhat unfavourably the sense of humour shown by the audience.

The Society met on Thursday, the 2nd November, with the Vice-President in the chair.

N. Duncan proposed the following motion:—

"That in the opinion of this house Modern Dress is neither comfortable, healthy nor picturesque." The mover showed the uselessness of many articles of apparel which it is customary for men to wear, the expense they incur in getting them and the proportionately small good they derive from them. also mentioned that ladies' attire was very costly and, considering the fickleness of fashion, put their husbands to great expense in defraying its cost. He went on further to say that young officers, who ought to be thinking of the defence of their country, were stalking about in fine clothes with feminine vanity.

E. F. Berry opposed the motion. He said he could not see that any article of modern dress was useless, if it was not comfortable it added to one's good looks, and that if a man could not keep up with the fashion he was not compelled to, that it was a matter left entirely in his own hands. Nothing could be more absurd than to see officers of the British Army dressed carelessly and without a proper uniform.

H. L. Neligan seconded the motion.

He said that modern feminine attire was more comfortable and picturesque than that of the opposite sex. He showed the absurdity of certain hats and the encumbrances due to the modern style of dress.

The motion was carried by 19 votes to 4.

The Society met on February 16th, with the Vice-President in the chair.

C. J. Butler read a paper on Napoleon.

The essayist began by denouncing those historians who have stigmatized Napoleon as a usurper. He maintained that the French people placed him on the throne of their own accord, and that he was always beloved by his subjects. He denied that Napoleon was—as he is often described—a blood-thirsty monster, who looked on his men merely as food for powder, and he affirmed that he used to weep over the carnage of the battle-field and tenderly press the hand of the dying. He was not a traitor to Italy; he never used his power for his own aggrandizement, nor were his wars provoked by his arrogance.

Before turning to Napoleon's life the reader informed the House that he was his ardent admirer, and begged to be excused for any statement which might savour of prejudice; but that he firmly believed that all he had written was true. He then gave us a most interesting and instructing account of Napo-

leon's life. He made the most of Napoleon's good points, and suggested various excuses for his defects. He maintained that when Napoleon had practically conquered Europe, all the other powers found it necessary to prove that he was a tyrant, and by spreading false reports to turn the people against him. The essayist, after giving us a pathetic description of Napoleon's life in exile at St. Helena, closed his paper by stating that the liberties of Europe were lost at Waterloo.

After various questions had been asked and answered, N. Duncan proposed and D. M. Johnston seconded a hearty vote of thanks to the author of paper.
