EDITORIAL.

THIS number, it will be observed, is the first of a new volume. The next number will be the second. The term has been a useful one, uneventful, though "School Notes" form a large item in this issue. The weather of the term has been remarkable for alternations of spells cold and spells warm. Most of the training for the Sports was assisted by dry tracks and bracing breezes, as were the Sports themselves. This was an interesting meeting,

resulting in some very creditable performances and one that may be termed epoch-making. Duncan's hundred. identical in his heat and in the final, would, perhaps, making the necessary allowances, have been 10 3-5ths seconds. He is a sprinter of a high order, and might well hope to be best in a good year at the 'Varsity. We wish him all success in the "Public Schools" Hundred, for which he is entering. Graham, who won the Challenge Cup, should soon be a distinctly good man in the High Jump and long distance events. He was evidently out of condition on the Sports day. The Past v Present Sports of April 7th, were the best meeting hitherto held, both in weather, attendance and athletic performance. The Past won by 6 to 3, but the competition was closer than this suggests, and four records were broken.

FOOTBALL.

A.S.F.C. v. Old Abingdonians.—This annual match was played on the School ground on Dec. 20th. The Old Boys had a strong team out, and the School was fully represented. We won the toss and played into the Park goal. The Old Boys scored immediately after the start through Payne, and a few minutes later A. W. Miller got another goal. Then the School got one from a shot by Parker, after Smith had sent in a good shot which hit the posts and rebounded into play. This was all the scoring up till half-time. A few minutes after the re-start the Old Boys scored through A. W. Miller. Play continued to be fast, and Smith got a good goal for the School from a difficult angle. Aldridge should easily have saved the next two goals got by the Old Boys, one of them rolling slowly between his legs. A. W. Miller was responsible for these two goals. About 10 minutes from the end, R. V. Weaving collided violently with somebody and had to leave the field. The School played up well and got three goals through Harvey and Leach, while the Old Boys added the odd goal through Payne.

CONCERT.

The School Concert was held in the Gymnasium on December 16th, and was a great success. It is again our privilege to express our gratitude to Miss Hughes, who was invaluable at the Piano, and to our kind friends from the town, who assisted in the orchestra. The skill and verve with which they played were much appreciated by the large audience assembled. Perhaps their most successful effort was the wellknown fantasia from Cavalleria Rusticana, in which not only an intimate acquaintance with the music, but also a very distinct grasp of dramatic effect was conspicuous. N. Duncan and P.E. Andrews provided Piano Solos that were much above the average, the former's rendering of Mendelssohn's Liebeslied being noticeable for sympathy of touch, and Andrews' performance of Chopin's Nocturne showing very marked powers of execution. In Dickenson we seem to have discovered a Soprano of great ability. His fullness of tone, clearness of enunciation and power of expression are really remarkable in a boy of his age. He sang German's "Who'll buy my Lavender" in the first part and Handel's "Where e'er you walk" in the second. As an encore he gave us "I'll sing thee songs of Araby." a daring but thoroughly justified choice.

Mr. Martell much delighted his audience with Elgar's "The Pipes of Pan," a song that gave full scope to his large compass. In the second part he gave a sympathetic rendering of Harraden's "Ships that pass in the

night." As encores we had "Three for Jack," "The Little Irish Girl."

The Choir received well deserved applause in a couple of part songs, and there was a good rendering of Schubert's "To Sylvia" by the School Quartette. The hand of time unfortunately necessitated the deletion of their second item, and also brings this account to a close.

THE LITERARY, SCIENTIFIC AND DEBATING SOCIETY.

Thursday, Jan. 25th, saw the Society meet for the first time this session in the Pembroke Room, with the Vice-President in the chair.

H. L. Neligan proposed that in the opinion of this house "Members of Parliament should be paid by the state." He argued that England is the only country where Members of Parliament are not paid, and as all other nations think it right to pay their politicians it is very improbable that England should be right. He went on to say, that as it now is, Parliament may be likened to a club which a rich man may strive to enter, not from political motives, but "for the fun of the thing," as the slang phrase expresses it. Another point brought forward by Neligan was that Parliament is only open to the rich, and therefore is not a true representation of the nation, whereas if the sum of £500 were to be given to each member, it would put aside this difficulty, and only increase the income tax by about \frac{1}{3} of a penny.

D. M. Johnston in opposing the motion declared that members were repaid in other ways for the services they rendered to the state, by an increased number of briefs if at the bar, by an increase in commercial value as directors of companies, or by the improvement of their social position, that it has often been proved that one nation may with advantage stand alone in a certain policy. Labour has been represented by labour,

as the late election has shown. It would be a pity to see the dignity of the "Mother of Parliaments" lowered by its members having to receive a paltry annual stipend. Johnston concluded by saying that if every such matter was to be accomplished by public money, the taxes would rise to 20 shillings in the £.

Chappelow seconded the motion. He maintained that Members of Parliament would do their work more thoroughly if they were conscious that their labours were paid for. Socialism was making rapid strides, and why not in England? It would raise the working man to a better sense of his part in the government of the nation.

The following members also spoke:—Con.: H. H. Gibson, Esq., R. J. Weaving, B. M. Challenor. Pro.: R. V. Weaving. The motion was lost by 4 votes to 13.

The Society met in the Pembroke Room, on Thursday, Feb. 1st., with the Vice-President in the chair.

In the absence of M. A. Butler, D. M. Johnston was called upon to propose that in the opinion of this house "the loss of British supremacy in sport is of very serious importance." His argument ran on the lines that England owed her empire to her Navy, which did not lie in the ships themselves, but in the physique and training of her sailors. He said that this physique was due largely to the sports, which form, to a great extent, a part of every Briton's life.

N. Duncan, in opposing the motion, pointed out that the sons of England

did not look for support in their fights on sea and land, so much to the rowing and football they had engaged in, as to the stern discipline and military training to which they had been accustomed.

T. Johnston, in seconding the motion, said that the loss of supremacy in sport was indeed serious, for unless men engaged in sport, they would soon lose that robust health which had been Britain's boast for so many years. He complained that dwellers in the East End of London had no possible chance of building up their strength.

R. J. Weaving, seconded by H. L. Neligan, proposed as an amendment to the motion that "in the opinion of this house Britain has not lost her supremacy in sport." E. F. Berry spoke against the amendment. The following members also spoke, Rev. T. Layng and Mr. H. Gibson. The amendment was carried by 14 votes to 1.

The Society met in the Pembroke Room, on Thursday, Feb. 8th, with the Vice-President in the chair.

R. V. Weaving, in proposing the motion, that "In the opinion of this house every male adult should be entitled to one and only one vote," said that since there was so much education and higher education among all and even the labouring classes, men who were not rich were quite as competent to have two or more votes, as those who possessed this privilege simply because they owned land in different districts. He went on to say that he did not see why a man should have more votes, because he had more money; and he should like to see

everyone, excepting of course criminals and lunatics, with equal rights.

R. J. Weaving opposed the motion, he said that the proposer's "Higher Education" was an entire misnomer, that the education given to the poor was far from being very good and that what they did receive, by no means in itself made a man competent to deal with problems tasking the intellectual powers of the most learned men.

M. G. Brinsmead in seconding the motion, argued that the voting register would be far less complicated than under the present conditions and would save both time and money if we simplified our system. He also showed that if we were to judge a man's capacity for voting by his property we need not necessarily look to people who owned two houses in different constituencies.

The President proposed as an amendment "That this House would welcome a simple and well-considered system of manhood suffrage, but refuses its assent to the principle of one man vote," this was seconded by R. J. Weaving.

Mr. H. H. Gibson spoke against the amendment.

The amendment was carried by twelve votes to one.

The Society met in the Pembroke Room, on Thursday, Feb. 15th, with the Vice-President in the chair.

The motion before the house was that "in the opinion of this house the training of the British Officer is the best in Europe."

G. F. Moore was called upon to propose the motion. He gave with full

details the army training of most of the first class powers on the continent and especially that of Germany. He gave their studies before, during, and after their time at the military colleges; the time devoted to theoretical and practical work, in fact the whole curriculum, and closed by making a comparison with England, favourable to this country.

C. J. Butler opposed the motion; he maintained that England was not training her soldiers well, and as a proof of this statement referred to the late Boer War. In this war, he said that the English officers had by no means shown that efficient training which the proposer had described; they had lacked that staying power so necessary in battle and had no idea of good military management. He went on to say that it was no uncommon sight to see the effeminate young officers dressed in the height of fashion attending balls and operas to the detriment of more warlike exercises.

E. F. Berry in seconding the motion, argued that the British officers had done splendid service in the Boer War. As an extenuation for their accidents, he showed how the Boers had been preparing years before for the war, and that the English were unacquainted with the ground they fought on.

A feature of this debate was a hot controversy between the opposer and seconder, in which each rose to speak several times.

Gibson and R. J. Weaving.

The motion was lost by 5 votes to 9.
The Society met on Feb. 22nd, with the Vice-President in the chair.

E. B. W. Chappelow read a paper on the supremacy of Ninevel.

The essayist began his paper with a short sketch of the mythology, government and customs of ancient Assyria. He then gave an account of the rise of Assyria after the breaking up of the Egyptian empire in Syria. He then dealt with the early history of Assyria until the accession of Sargon, B.C. 722, treating at some length of the wars of Tiglath Pileser I., B.C. 1120 and Assur-nazir-pal, B.C. 870. The real subject of the paper was then entered upon. Sargon began a new dynasty. The reader pointed out that this was the most prosperous period of Assyrian history, whose glory reached its culminating point in the reign of Asshurbani-pal. Some account was given of the captivity of the Israelites by Sargon, of the wars with Merodach-Baladin, king of Babylon, but a much longer account was given of the conquest of Egypt by Sennacherib, 674 B.C., his wars with Tirhakah and the final destruction of the Assyrian power in Egypt by Psamtek, King of Memphis and Sais. Asshur-bani-pal died in the year 626 B.C. The Assyrian empire soon declined and Ninevel fell in the year 605 B.C.

After several questions had been asked and answered, N. Duncan proposed a hearty vote of thanks, which was seconded by D. M. Johnston, and carried unanimously.

THE SPORTS.

The School Sports were held this year on Saturday, March 31st, and the... day though not very warm was sufficiently so to content us after the bitterly. cold weather we had experienced during training. The attendance too seemed to us quite up to that of last year, whilst the times and distances in most instances compared very favourably with those of previous years. Duncan's "hundred" was a truly magnificent performance, even allowing for the downward gradient of the track; his heat in the Hurdles quite good and his long jump better than last year's result. Butler did a fine "put" in the weight and should do even better. Smith won the Quarter from the 8 yards mark in really excellent time, for it is no easy matter to run through a field of 40, and Berry finished strongly in the Halfmile. The Old Boys' race produced as tight finish, R. G. Rice just winning.

Mortleman iii won three firsts in the Junior events and was also second in the Weight. Rice iii did well to win the Choir race from scratch, though the time was not so good as last year.

Among the younger boys Napper shews great promise and Kaye ii. and Collingbourne also did well.

The prizes were distributed by Mrs. Estridge. After this three cheers were given for Mrs. Estridge, for the Ladies of Abingdon, for the Prize Donors and for the Head Master.

The School Mile was run on Monday, April 2nd. There was a large field and most of the starters finished. The runners kept well together for the first four laps, but on entering the final round Graham and Smith raced away, the former finishing strongly and winning by fifteen yards. Neligan was a good third.

The winner of the Challenge Cup will be decided after the School Steeplechase which is run on Wednesday, April 4th. At present Duncan has 38 points and Graham IV. 30.
