SCHOOL NOTES.

We offer our humble congratulations to Mr. and Mrs. Reynolds on the birth of a second daughter. Likewise to Mr. Bevir on his marriage, and we take this opportunity of extending to Mrs. Bevir a hearty welcome into the circle of our Abingdonian community.

Mr. C. A. Pryce, whose death we record, was for over twenty years a member of our Governing Body and took an active part in its administrative labours. As Clerk to the Abingdon Exhibition Fund (Maintenance Grants) he was especially concerned with the Local Scholarship-holders, many of whom owe much to his kindly interest in their welfare. He had been in failing health for some time past and resigned his position as a Governor a little over two years ago.

In his time, as man of affairs, churchman, and philanthropist, Mr. Pryce had been among the most prominent of Abingdon townsmen. His profound knowledge of law-as a student he had achieved some of the highest honours in his profession—enabled him to discharge with distinction the many public offices which fell to his lot. As a County Court officer (Registrar and High Bailiff), as a Borough Councillor, Mayor ('96—'97), and Alderman, and later as Clerk to the Borough Justices, his services were invaluable. For many years he was a Governor of Christ's Hospital, and on three occasions Master. On two occasions he stood for Parliament in the Liberal interest, and on the first (1892) came very near to victory.

For upwards of forty years he had been a widower, and when his only son, A. O. C. Pryce, O.A., was killed in the war in 1918, there were few who knew better than his old schoolfellows of Roysse's how great a loss the father had sustained.

It has been designed to fill in the entire east end of the room with a sloping floor up to the top of the steps, and to house the properties which we hope will soon be forthcoming.

O.T.C.

LITERARY AND DEBATING SOCIETY.

The second half of the 1926-7 session was somewhat slack, only three meetings being held. During the session Messrs. E. A. Passam, J. A. Squire, F. W. Jennings and R. S. L. Robinson were elected to the Society, the officers remaining as before.

Our first meeting was held on Saturday, February 5th, with the Vice-President in the chair. Honorary Treasurer proposed and Mr. S. E. Clark seconded the motion that "In the opinion of this House, respectability is the bane of civilization." The Honorary Secretary and Mr. A. M. Thatcher opposed the motion. Mr. Ingham, Mr. Gardner and the Vice-President spoke for the motion. Mr. O. T. M. Raymont spoke but favoured neither side. The motion was carried by 8 votes to 6.

The next meeting again saw the Vice-President in the chair on February the 12th. In private business the Hon. Treasurer proposed and Mr. S. E. Clark seconded a motion that "in debate, the Proposer of the motion, and not as hitherto the Opposer, shall be the last to sum up." This addition to the rules was carried by 13 votes to 1.

The motion at this meeting, that "in the opinion of this House, the surest way to secure peace is to prepare for war," was proposed by Mr. E. G. Langford, seconded by Mr. C. J. E. Steff, and

was opposed by Mr. T. G. Austin and Mr. E. P. Rice. The following members also spoke: Pro, Mr. Hillier; Contra, Mr. Hall, Mr. Banes, Mr. Clark, Mr. Gardner, Mr. Ingham, Mr. Lansdown, the Hon. Treasurer; Neutral, Mr. Thatcher and the Hon. Secretary.

Three members voted for the motion, and twelve against.

Our third and last meeting was held on Saturday, February 26th, with Mr. S. E. Clark in the chair. Mr. A. M. Thatcher proposed that "in the opinion of this House, machinery will eventually entirely supersede manual labour." Mr. D. J. W. Hillier seconded the motion, and the Hon. Sec. and Mr. C. R. Hall opposed. The following members and visitor also spoke: Pro, Mr. Rice, Mr. Baumann; Contra, the Hon. Treasurer, Mr. E. G. Langford, Mr. Fabes, Mr. P. J. Squire, Mr. K. C. Smith. The motion was lost by 6 votes to 8.

Viewed as a whole, the 1926-7 session may be regarded as fairly successful, consisting as it did of 8 debates and 2 lantern lectures. It must be admitted, however, that the enthusiasm which showed itself in the first half seemed to wane rather rapidly in the second. But such, perhaps, is the way of Debating Societies.

UNIVERSITY LIFE IN LONDON.

My object in constructing this brief article is threefold. (My readers will, I hope, forgive me for

"getting off the mark" without any beating about the bush, or any exhibition of a neat literary style,

which I do not possess).

My aim, then, is, firstly, to record the experience gained in a three (approx.) year course in the University (for what it is worth); secondly, to make known generally what are, in my opinion, the chief advantages and disadvantages attending study at the University as compared with a similar course at Oxford or Cambridge; lastly, to provide, in a word, "fodder for the guns," for in the last few months I have felt as every O.A. should feel, that it was about my turn again to provide something for this most excellent magazine.

(I need hardly say that the italics are mine and

are not a suggestion of the Editor's !!)

Perhaps before finally getting to work I may be allowed to apologise for selecting a rather uninteresting subject with which to eke out my turn. I can only defend my selection by emphatically denying the possible (??) rumour that I am one of the coming budding poets!

And so to work.

Before attempting to describe the life of an average student of the University, during term, it is necessary to say something about the University itself, and in particular its constitution. University, of course, is quite unique. It is the largest in the country and possibly in the world. although some of the American universities, if we include their evening technical classes (as at Chicago), run it close in numbers. Many of the students in London are women. In University College alone there are between three and four thousand students, and of these more than one third are women. Contrary to general notions there are two and only two true colleges of the University; namely, University College and King's College. But in addition to these there have been created what are called "Schools to the University "—a most extraordinary institution, to my mind. The Imperial College, (comprising as integral parts the Royal College of Science, the Royal School of Mines, and the City and Guilds College), of which I am proud to have the honour of being a member, is so classed. It, consequently, is of this College that I shall have the most to say.

The other "Schools" to the University are, briefly, Birkbeck College, Gresham College, East London College, The London School of Economics, Royal Holloway College, Bedford College (for women), Battersea and Chelsea Polytechnics, Finsbury Technical College, The London School of Oriental Studies, the Hospital Medical Schools, and others. This conglomeration is known as the University of London. It is manifestly

ridiculous that such a college as the Imperial College should be classed with this miscellaneous collection. Birkbeck College also is worthy of true College status, and, may be, others.

Now a word as to geographical distribution. The administrative offices are housed in the Imperial Institute at South Kensington, and it is a rather ironical fact that the Institute is more or less surrounded by the various buildings and Colleges of the Imperial College with which it was so long "at daggers." In fact, in Imperial Institute Road, described by *The Times* as "that famous street in South Kensington" there is little else besides the Institute on one side and the main building of the Royal College of Science on the other; and for many years these two have glared across at one another. At last, however, an agreement has been reached into which I have not time to enter here.

The two colleges of the University are miles away from the administrative offices. King's is in the Strand and U.C. in Gower Street. Birkbeck in near Holborn, and the rest of the "Schools" are scattered about all over the place. Consequently the discerning reader will at once realise the great difficulties in the way of anything like a corporate University life. The recent troubles at Bloomsbury will indicate that efforts are being made to overcome these difficulties. But the very nature of London will always stand in the way of any such social life in the University as is met with (or supposed to be met with) at Oxford or Cambridge.

It seems to me that the only possible solution is the wholesale shifting of Colleges and Unions, all to one part of London; but the difficulties in the way of such a move, financial and otherwise, seem insurmountable.

Now in addition to this scattering of the Colleges there is very poor provision for residence. Hostels and Halls are known, but they are the exceptions rather than otherwise, and in any case are quite inadequate as regards size. Consequently many of the full time students live in "digs" (uncertified and under no jurisdiction from the College), and an equally large number live at home. It was my misfortune to belong to the latter class. Although it only took me an hour to get to College each day and home again in the evening, it seemed an awful waste of time; but when I considered the plight of the men I knew who came up every day from such places as Brighton, Bedford and Reading, I thought myself lucky.

But it seems to me the chief trouble of living

at home is that of getting the work done. For a fellow who has been a boarder at his public school the endeavour to settle down to work in an atmosphere foreign to any serious study is very difficult. At School one is surrounded by fellows doing the same sort of work at the same time, and the sudden change from such a congenial atmosphere to that of the normal home is very upsetting; especially for the Freshman at the University of London. Of course, in time one should get used to it. Personally I never did, and it is only recently that I have succeeded in analysing my feelings on the subject, and have come to this conclusion.

In spite of these and similar difficulties the University is gradually finding more time for developing its social life. Each College has its Union. In London the Unions serve a fuller purpose than the more elaborate Unions of Oxford and Cambridge. The Union forms the general meeting place for all the students, and in connection with it are run all the clubs of every conceivable branch of athletics and all the various societies and social clubs. In the case of the Imperial College the Union forms the restaurant where all the students lunch, it provides a stationery shop, and is in fact the complete social centre of the College. It also, of course, provides smoking and bridge rooms, gyms, etc., and all the normal social gear.

Every conceivable type of athletic club is run, but in most cases it requires no small amount of courage to become a regular "patron." In

my own case, unbelievable as it may sound, it required on my part a sacrifice of 5 hours of my time in order to get a game of soccer of approximately one hour. The other four hours were occupied in changing and travelling to and from the ground; which in the case of the I.C. is situated at Wembley. When I had the pleasure of belonging to the Boat Club (a pleasure which was abruptly stopped by appendicitis) I was somewhat better served, as I only had to travel to Putney, half the distance of the Wembley journey.

My case will serve to show the difficulties in the way of anything like serious sport. Yet in spite of this the Imperial College Boat Club has six "eights" out every Saturday morning; the Rugger Club runs approximately seven or eight "fifteens," and the Soccer Club a similar number of "elevens"; tennis, golf, boxing, etc., are also represented, and among other scalps the Fencing Club last year obtained those of both Oxford and Cambridge.

What I have said will have shown sufficiently well that the University of London is a University of which any O.A. might be proud to be a member, and I hope that in the future we shall have more representatives of the School up here. During my three years we have had three representatives in the Imperial College alone; R. M. Hodgson, who is now doing the Chemistry Course in the R.C.S.; H. W. Beak, an O.A. of Mr. Layng's time, who was in the R.S.M., and lastly

FOOTBALL.

This year has been even more unfortunate than last as regards the House "Sixes." The ground, for days at a time, has been quite unplayable, and it has only been found possible to complete one round and about half of a second.

Points in the first round were gained as follows:

—Green House 112, Red House 69, Blue House 54. A total of thirty-eight games was played. Keenness was shown as usual—not to speak of a certain amount of strong feeling.

ROWING.

The season has been a disappointing one. Snow, sickness and floods have contributed towards the general discomfort of February rowing. No rowing colours were left from last year, and the nucleus for two crews consisted of the previous "cox." Something had to be done; and tubbing of the most likely candidates was carried on for a period of a fortnight, without bringing to light many 'hopefuls' or even 'possibles.' However, eventually eight sportsmen were selected to fill the various places, but it was very difficult to shape them into anything resembling a crew. No serious work was attempted until they had become accustomed to the light boats, and this was only a week or ten days before the first race.

Of the First Crew "stroke" certainly showed improvement, but the individual faults are too many to enumerate. Unfortunately, it must be confessed that with regard to the others their improvement was retrogressive, and the fact of being in a light boat seemed to exaggerate their difficulties. A fact that is not fully realised by young would-be oarsmen is that there is only one right, but many wrong ways of carrying out the various complicated movements that go to form a complete stroke; and it needs a good deal of perseverance and concentration to overcome the natural tendency to do the thing in the wrong way. Circumstances prevent much individual coaching when once the crews are provisionally selected, and therefore it is all the more necessary to adhere to the advice given during the early stages.

It seems improbable that there will be many left to form material for next year, but it is hoped that some of the younger members will provide more "promise." Adverse conditions—flood and wind—make instruction impossible for the inexperienced, and their opportunities are in consequence somewhat limited; but it is very important to acquire good habits from the start.

THE RACES.

The School versus O.A.s.

This race was rowed on Culham Reach on Saturday, February 26th, conditions being singularly adverse. The river was very high, and there was a strong enough wind to cause a considerable amount of choppiness. The O.A. crew consisted of K. T. Wood (bow), W. G. Cullum, H. D. Stiles, K. C. Smith (str.), and T. Haynes (cox). The School won the toss and chose the Berkshire station, which was the more protected. From the first stroke of the race the School gained, although near the beginning it was thought that the O.A.s. were holding their own. The rowing of neither crew was conspicuously good, but the School maintained a better time, and won easily.

The School versus Magdalen College School, Oxford.

The races were rowed at Abingdon on Saturday, March 5th, under still more unfavourable conditions than prevailed for the O.A. race. Magdalen won the toss in each race, choosing the Berkshire bank, and gaining thereby a considerable advantage. The First Fours rowed first, and the race resulted in an easy victory for Magdalen. Magdalen gained steadily from the start, and at the Minute Tree had got a substantial lead of over a length. Both crews appeared exhausted at half way, though the form of the School Four seemed to improve. The time for the race was 4 min. 16 sec.

In the Second Fours' race the School crew met with much the same fortune as the First Four. The School got a bad start, and Magdalen drew steadily away. They appeared to be in better condition than our crew, and their lead increased till the finish, the final number of lengths not being determined. The time taken was 4 min. 35 4-5th sec., the apparently slow time of both races being accounted for by the bad conditions.

ATHLETIC SPORTS.

The School sports were held in the Upper Field on Saturday, March 19th, in lovely weather. Although a large amount of rain had been experienced, the track had dried surprisingly quickly and was in fairly good condition.

Owing to the heavy losses which our athletic talent has sustained since our last Sports, no extraordinarily good results were obtained, although some of the events reached quite a creditable

standard.

THE STEEPLECHASES.

The Steeplechases, which were to have been run on Thursday, March 10th, but which had to be postponed owing to the flooded state of the Common, were run on Tuesday, March 22nd,

instead. The day was almost ideal, the Common being drier than it has been for some years, but a strong wind prevailed, which checked the runners somewhat at the outset.

The Junior Steeplechase (under 14) was run first. The event was won fairly comfortably by E. F. Slatter, D. P. Edsall gaining second place. G. J. Goodey, who was third, was unfortunate in being beaten at the tape by a matter of inches. The time was 7 mins. 20 2-5th secs. Red House gained the greatest number of points, Green House being second.

The Senior Steeplechase was run immediately after the Junior. S. E. Clark, W. W. Brown, and J. W. P. Martin got well away at the start, thus avoiding being hampered by the field at the first ditch, and were bunched well to the front throughout the race. These three runners had strung out a little by the water jump, the order of crossing being S. E. Clark, W. W. Brown, J. W. P. Martin, S. A. Fabes, E. G. Langford. This order was retained until the finish, S. E. Clark winning from W. W. Brown by five or six yards. S. E. Clark's time of 12 mins. 10 1-5th secs. is one of the best times run since the record was established in 1922. As was the case in the Junior Steeplechase, Red House scored the most points and Green House won the second place.

The twenty-eighth School v. O.A.C. Athletic Meeting was held in the Upper Field on Saturday, March 26th. There was a strong and cold wind, but fortunately no rain. CORRESPONDENCE.

Sir,
I should be obliged if you would allow me a small portion of your valuable space (one should always start off like this when addressing an Editor!) to correct an entirely erroneous impression that I fear I created during the short talk on Radioactivity that I recently had the honour to deliver to the School Literary, Scientific and

Debating Society.

A question was put to me by Mr. J. F. Sinclair, which, if I remember correctly, had the following

purport: "Has any actual transmutation of one element into another been accomplished, and if not, is there any probability of any such change

being accomplished in the near future?"

I regret that I made the entirely incorrect reply

that no such change had been achieved.

Mr. Ingham was kind enough to correct me at once, with facts with which, as a matter of fact, I was acquainted, but which had escaped my memory. Since then I have re-read the literature on the point and I find the following facts:—

In June, 1919, Sir Ernest Rutherford published results of experiments he had just completed. He described how, by the projection of alpha particles from a radioactive source through Nitrogen gas, particles of smaller mass than Nitrogen atoms were expelled from the latter and were identified as Hydrogen nuclei. Thus we have the artificial decomposition of Nitrogen atoms, i.e. the change of

Nitrogen to Hydrogen. This is in fact the first proved case of transmutation, the change that has been occupying mankind since a time which was certainly hundreds of years B.C. Following on with this work Hydrogen particles were obtained from Boron (a solid), Fluorine (gas), Sodium, Aluminium and Phosphorus (solid), by similar methods of treatment.

It will thus be seen that it is not merely the heavy radioactive atoms that are built up of simpler atoms (a view long held owing to their disintegration), but also the simpler light atoms of such a gas as Nitrogen (atomic weight 14) that are composite. We are thus thrown back on the hypothesis of Prout enunciated over 100 years ago that the atoms of all the elements are built up of Hydrogen atoms. But the Hydrogen atom is itself complex, being built up of one charge of positive electricity (called a Proton) and one charge of negative electricity (called an Electron). "Electricity then is the long sought for primoidal matter of which all elements, and consequently the whole material world, are constructed."

Lastly, Sir, it is interesting to note that this transmutation has resulted in no world-shattering explosion, earthquake or other picturesque catastrophe, as is so frequently forecast by the "ignorami," if I may coin a word, of a certain section of the press. Also that in the transmutations thus brought about there occur no noble

metals. In fact, although dozens of elements have been subjected to this method of attack, only in the six cases enumerated have successful results been obtained. We need therefore have no fear for the present of any wholesale transmutation of base metals into gold, with its consequent

result, the disappearance of the existing currency. This, however, is an interesting situation to contemplate, and I will leave it to my readers.
