#### ROWING.

The past season can be regarded as eminently satisfactory. Not only did we manage to preserve an unbroken record of successes in the races, but for some time we had as many as five crews on the river simultaneously, thus providing a nucleus of possible material for the years to follow. It may here be noted that the chief weakness lies in the lack of promising coxswains, who usually require a somewhat lengthy period of training before acquiring the necessary qualifications and experience.

Conditions were on the whole more favourable than in recent years, in so far as no floods were encountered and therefore no very violent stream, and rowing and tubbing was not only possible but safe for the most part. We are getting accustomed to the vicissitudes caused by the ravages of illness at this treacherous time of the year, and this year was no exception.

#### FIRST IV.

At the start of the season the 1st IV seemed very well placed with three old colours available— G. V. Bayley, the Captain, J. M. Wood, stroke and P. H. Wooster. With some useful material to call upon in addition it would have seemed simple to fill the one place vacant; unfortunately in spite of all his efforts Wooster could not settle down at bow, where his weight required him to be, and he had to be relegated to the 2nd crew, where, by way of some consolation, his stroking was invaluable. A. C. Dean soon settled down as an efficient and powerful "3" and H. T. Jones fitted in well at bow. The great feature of the crew was their length, due to the remarkably elastic swing of Wood at stroke. He more than fulfilled the promise of last year, and his steadiness and staying power were out of all proportion to his weight. With a long rhythmic stroke the rest of the crew could and did make full use of their weight, which was considerable; and as they were not disturbed by being led over the first part of the course they proved a combination hard to beat, and in fact were unbeaten. Altogether they were

a good crew and there was no luck about their success. J. A. Stephenson, though without previous experience, proved quite an efficient cox, and he made up in intelligence what he lacked in experience, and got on well with the crew. The trouble with coxes is that their weight increases with their usefulness and a featherweight with coxing sense is hard to find.

#### FIRST IV CHARACTERS.

- H. T. Jones (bow), 11 st. 2 lbs. 2nd IV, 1937. Rather heavy and thick for a bow but improved steadily in his swing and reach. Bladework quite good and got his work on well.
- G. V. Bayley ("2"), 11 st. 4 lbs. Captain. 1st IV, 1937. Shewed great improvement on last year, and rows better on stroke than bow side. Steadier forward and so worked more effectively, though inclined to scamp the finish. A very efficient captain who lightened the labours of coaching.
- A. C. Dean ("3"), 11 st. 10 lbs. 2nd IV, 1937. Fulfilled all expectations and with more experience should be a very good oar. Rather stiff and should open out more at the finish, but does a tremendous amount of effective work.
- J. M. Wood (stroke), 9 st. 12 lbs. 1st IV, 1937. The best stroke we have had for years. Length and rhythm as good as last year and bladework better. Kept his crew going as steadily when led as when leading.
- J. A. Stephenson (cox), 6 st. 10 lbs. Learnt his job well in a short time. Steered well and used his voice judiciously, though his vocabulary was rather limited. Very good ear for the towpath.

#### FIRST IV RACES.

- v. O.A.'s on Saturday, January 29th, at Abingdon. Won by  $4\frac{1}{2}$  lengths in 4 mins. 9 secs. Not much stream but a strong S.W. wind. The School were  $\frac{1}{2}$  length up in 20 strokes and thereafter rowed a long steady stroke with plenty of power. The O.A.'s were nicely together but lacked the necessary pace.

- v. Keble College, on Saturday, February 26th, at Abingdon. Won by a canvas in 3 mins. 31 secs. Strong wind up the Reach and rough water. This was an excellent and most exciting race. At

the Big Tree, in spite of a fairly good start, the School were  $\frac{1}{2}$  length down, but a good "10" brought them up and at the Drain they were only 3 ft. down. Each crew spurted in turn and the School just managed to gain the verdict. A remarkable example of cool-headed stroking backed up by the whole crew.

v. Magdalen College School, Oxford, on Wednesday, March 2nd, at Abingdon. Won by 2 lengths in 3 mins. 37 secs. Weather sunny, little stream, slight cross wind. The School won the toss and took the Berks side. The start was rather dirty but they quickly got into their stride and were actually a canvas up at the Big Tree—though Magdalen were rowing a much faster stroke. Thereafter they lengthened out and using their weight well gradually drew away, though Magdalen made a good effort at the finish. For once the School more than held their own in the first minute, and the moral, if not practical, effect was decisive.

#### SECOND IV.

With several members of last year's crew available we hoped to be able to make an early arrangement of the crew, but the final composition was greatly hampered by the prevalent "flu," and the crew rather severely handicapped by the continuous changes.

In the later stages of training the inclusion of Wooster at stroke, whose previous experience was invaluable, served to stiffen up the composition of the 2nd crew considerably; also, with Carter as cox for a second season and Cracknell at "3" it was anticipated that it would prove to be a crew very much above average and so it was.

It must be admitted that the new boat was a distinct acquisition, being easy to sit and a fast mover when the necessary power to propel it was forthcoming.

By way of criticism, the tendency towards shortness was at times rather prevalent, though this was not by any means conspicuous in the races. Usually rather slow off the mark, the crew settled down well after the first half minute and kept going very strongly without any loss of form, using their legs to good purpose. Blade work, though a trifle untidy in the early stages, improved a good deal later. The crew must be congratulated on their performance in the various races in which they showed great determination and spirit and rowed with commendable consistency, readily backing up each other and giving of their best.

The School received  $\frac{3}{4}$  length start to compensate for their opponents rowing on slides, and though they were only  $\frac{1}{2}$  length ahead at the Big Tree, Wooster put in some well judged bursts and drew away comfortably. Though the crew was not perfectly together it was a good row and fast time.
- v. M.C.S., Oxford, on Wednesday, March 2nd. Won by  $\frac{3}{4}$  length in 3 mins. 50 secs. This was a very fine race and shewed the crew at their best. Magdalen won the toss and were  $\frac{1}{3}$  length up in 2 mins. Wooster spurted and drew level, and after each boat had shewed ahead, the School drew away distinctly in the last 100 yards. A splendid ding-dong struggle.

Owing to illness the House Races for the Bennett Cup could not be held—but some scratch fours were rowed on the last Saturday of Term. The light boat race was won by: R. F. Jackson, D. E. Roberts, H. T. Jones, P. H. Wooster, J. N. Paige (cox), and the tub fours by D. G. Carter, D. Pimm, H. B. Bailey, G. L. Logan, J. P. Aldersley (cox).

#### HOCKEY, 1938.

It was unfortunate that circumstances prevented more than one match being played, as the standard of play in practice games was quite promising. Players are beginning to realize the importance of anticipation, and the effectiveness of placing passes rather than hitting blindly.

The team which beat Wantage School 4-3 was a better-balanced one than we have had for several years. The forwards, though lacking in skill and finesse had plenty of speed and dash, especially on the wings, Randall in particular putting in some good runs and centres on the right. The halves played constructively, and the backs were individually sound, though they did not cover each other well enough. Faulkner shewed that he had a very good eye, and would deal with the most awkwardly bouncing ball in masterly fashion. Mitchell is improving in goal but does not come out far or frequently enough. Undoubtedly many of the shortcomings mentioned above would have disappeared if more matches could have been played, and it may safely be said that this was the most promising team we have yet had.

School v. Wantage School. Away. Won, 4-3.

Playing downhill in the first half we were soon attacking and Randall ran in from the right wing to test the goalkeeper with a hot shot. Soon afterwards a good pass from Randall led to our first goal, scored by Paige. Later Lines beat the defence with a shot which went high into the net. Wantage worked the ball up their left wing and scored.

After half-time Randall was practically a passenger owing to a blow on the foot. This reduced the effectiveness of our attack considerably and play was fairly even. Each side scored two goals, Lines being responsible for both of ours Towards the end Wantage pressed hard, but could not draw level, being kept out by the sound defence of our halves and backs.

#### A.S.P.S.

This term witnessed the resuscitation of the Photographic Society. Thirty-four new members have joined, bringing the total to forty-four, which is the highest since its formation.

Two competitions have already been held, the Holiday Competition being won by R. F. Jackson with "Sunset" and the "People in Action" competition by P. H. Wooster with "A Good Putt."

On the evening of Sunday, May 22nd, R. F. Jackson gave a very interesting lecture on "How

to Develop and Print Films," and on the following Sunday an exhibition of Members' photographs was held in the Physics Laboratory. The photographs on the whole were very good especially those exhibited by R. F. Jackson and J. Stephenson. We are also greatly indebted to the Chairman, J. Y. Ingham, Esq., and to J. B. E. Alston, Esq., for exhibiting their collections of splendid photographs.

Both the School and Waste Court dark rooms have been used to a great extent and some very commendable results have been obtained. Waste Court members especially have mastered the art under the careful guidance and help of the Vice-President, E. J. P. Ross-Barker, Esq., and it is hoped that they will be showing some tinted photographs in the Founder's Day Exhibition.

### "NOW, I WONDER WHAT CAUSED THAT?" Some Common Photographic Faults Explained.

Many a time, when an amateur photographer receives his negatives from his dealer, or even when he first sees them after having developed them himself, he notes some peculiar result, occasioned by some fault in taking the picture, or in the camera itself. Then, if he hasn't seen such a thing before, he naturally asks himself, "Now, I wonder what caused that?"

#### LIGHT-FOG.

Perhaps one of the most common faults in negatives is that known as "fog," which means that actinic light (other than that which reached it in the normal exposure of the photograph) has reached the sensitive emulsion.

Some amateurs make the mistake of opening the camera before the film is completely wound off, but excluding such an obvious error as this, and taking it for granted that the dark room was "safe," we must look to the camera for the cause of the trouble.

One of the most prolific trouble-makers is the "pinhole," which merely means a tiny hole in the folding bellows of the camera, brought about by constant opening and closing: in other words, normal wear. If this hole is large the plate or film may be fogged evenly all over—or "veiled" to use the technical term. But if the hole is of the smaller variety, the matter of tracing it may to the uninitiated, be a long job. It may be foretold by the strange markings which it makes on the negative, resembling a tangle of string

(see Figure 1). This, of course, is caused by movement of the camera, making the ray of light through the pinhole dance all over the plate or film.



Another cause of fogging is a faulty shutter. This generally takes the form of circular markings in the centre of the film. If extraneous matter, such as sand, gets lodged in the shutter mechanism, it may cause the shutter to stick open, or partly open. Any such means of admitting light to the film can be traced by the simple means of placing a lighted electric torch inside the camera through the back, which is then covered over with a thick black cloth. The camera is taken into a darkroom, and then the light will at once show up any leakages. Another method is to apply the eye to the back of the camera which, of course, is opened, cover the back edge and the head with a black cloth and hold the camera in front of a strong light. The eye will soon detect any leakage which may be there.

Fogging along the edges of a film is caused by loose winding, and if this happens frequently the camera should be taken to a dealer or returned to the makers for adjustment.

#### SCRATCH-MARKINGS.

Long, straight lines on a negative, which resemble scratches, and which are, in fact, abrasions on the emulsion surface, may be caused by either

pulling the paper and film taut after removal from the camera—"cinch marks"—or by rubbing against the small rollers in the camera-back. It should be seen that these revolve properly before inserting a new film.

#### BLURRED PICTURES.

There are three ways in which a blurred picture can be caused. The photographer may move the camera at the moment of making the exposure, the person being photographed may move, or the camera may be incorrectly focussed. This last fault does not, technically, give a blurred picture, but one which is "out of focus." For instance, it is useless to take a snapshot with a boxform camera as close as, say, three to four feet without an extra lens to slip over the ordinary one, to adjust the focus accordingly.

Similarly, when using a focusing model camera, great care is necessary to estimate or measure the distance from camera to subject, and then set the focusing device accordingly. So many amateurs fail to realize the importance of this, and wasted film is the invariable result.

#### DARKROOM FAULTS.

In the darkroom quite a number of faults are common and a brief description of these, and some hints on how to cure them, will surely interest.



Figure 2. Cleanliness in the darkroom is a sine qua non if

first-class negatives and prints are to be made. Loose chemicals left lying about may cause an epidemic of spots which may result in the loss of many valuable exposures. Therefore, always keep your chemicals tightly bottled.

In development one of the most common faults

is that illustrated in Figure 2—Uneven development. It is more prevalent with plates and flat films than with roll films, which are generally developed in the roll.

This fault is usually caused by careless flowing on of the developer, or by the use of an insufficient quantity of solution. It can also be caused by unthinkingly putting the plate in the developing dish with the film side down, thus causing the plate to adhere to the bottom of the dish and preventing the solution acting evenly all over. Always use sufficient developer and flow the solution evenly and fully over the plate.

Another development fault far too common is that of clear circular spots on the plate which are caused by air bubbles formed on the plate during development. These bubbles are due to the use of stale or oxydized developer, or to flowing the developer too roughly over the plate. The bubbles attach themselves to the plate and prevent development.

Prevention. Always use fresh solution and flow it over the plate evenly and gently.

#### OTHER FAULTS.

Don't dry your negatives too near a fire or you



may get a result similar to that illustrated in Figure 3. The emulsion has melted owing to drying in excessive heat. Plates and films should be dried in a cool, dust-free place where there is a gentle current of air. Where quick drying of plates is essential bathe them in methylated spirit and place them to dry in a current of air. They will be dry enough to print from in a very few minutes.

Be careful how you handle your plate or film. The illustration in Figure 4 is the result of greasy fingers touching the emulsion before development. Handle the negative at the edges and this trouble will be avoided.

#### LONDON O.A.R.F.C., 1937-8.

There is only one thing to be feared more than a demand note for payment of Income Tax and that is the polite requests for news from an exasperated Editor. Desperately insistent and frantically polite (except once, when he referred to this contribution as "O.A. chatter!") he eventually wins hands down. All this, of course, has no bearing whatsoever on the London O.A.'s Rugger Season, but—well you can blame the Editor for that.

You will probably recall that in our last season's report, we harrowed you with tales of constant rain, a water-logged pitch and inches of mud. Profiting by these experiences we decided to move our pitch on to a higher plane. Its always so delightfully simple to make these decisions but to put them into effect is quite another matter. Moving a pitch means moving four goal posts and this means digging four pits; furthermore, moving a pitch means remaking "touch" lines and goal lines and 25's and things, and these fade away after a week unless you dig them. However, all

this was done, thanks largely to the brothers Wood plus their incredible plough-like "touch" line maker" (patent applied for). The club-house extension was, of course, completed by the commencement of this season and after suitable internal decorations had been effected with about a quarter of a mile of cerise and white coronation bunting and a griffon (J. This must surely be the only match in the year in which we really get that "lose the bottom of your stomach" feeling. It was grand and we hope you enjoyed it.
