

EDITORIAL .

The Lent term was not distinguished by any event of more than ordinary importance, but in a quiet way much was done and much was achieved. The weather, apart from the chilly rain of Sports Day, was good if somewhat cold. The athletic heats, standards and fixtures were successfully completed, occasionally in perfect conditions as on the afternoon of the O.A. Sports, and, even though the rains came to mar the annual Sports, a large number of parents and friends defied the elements to witness a full programme of events.

Hockey, perhaps had the best of the season and we were able to carry through the fixture list more fully than is usually possible during the Lent term. The decision to extend hockey facilities to a greater number of boys was fully justified by the enthusiasm that was manifest on all sides. After organised hockey had given place to athletics training, scratch games were continued and the keenness of those who took part, especially from Middle School, augurs well for the future of the club.

In other spheres, too, expansion continues. It is indeed good news that Crescent House will be at our disposal so much sooner than we expected, and that a new pavilion is under consideration. A more tangible sign of future benefit is the verdant carpet which now clothes the War Memorial Field, bringing with it a promise of much-needed elbow-room on the playing-fields.

And with the future, our thoughts are naturally upon the Coronation. Although an extended half-term will cover Coronation Day itself, the School will play a full part in the celebrations both before and after the event.

SCHOOL NOTES

We cannot allow Alderman H. G. Mullard to vacate the office of Mayor of Abingdon without expressing our very warm thanks to him for the interest he has taken in the School during his two years' tenure of office. We hope he will long continue to regard himself as an unofficial friend of the School.

He will be succeeded as Mayor by Alderman Percy Holmes, who is already well known to the School. We welcome Alderman Holmes to the Governing Body and wish him well as he faces the onerous responsibilities of Coronation Year.

The memorial service to the late Mr. John Etty is reported elsewhere in this issue. Christ's Hospital have filled the vacancy on the Governing Body of the School created by his death by the election of Mr. John Hooke. The choice is particularly happy for Mr. Hooke is President of the Old Abingdonian Club for the current year. We congratulate him on his election: we congratulate ourselves, too.

Recently the School had the privilege of hearing talks given by two members of the Governing Body. Sir Reader Bullard's illuminating "Report on America" is described more fully in the annals of the Turnor Society. Here we will merely thank him for the good offices which have secured for us a copy of Colonel Van Wagenen's book on "The Iranian Case". The other governor to whom we are indebted is Mr. Bredin, who spoke to all the Senior School on Thursday, 12th March, about the Sudan. As a former Governor of the Blue Nile Province, Mr. Bredin is particularly well qualified to speak on this topical subject: he must not take it as flattery when we say that his was one of the most stimulating and informative talks we have had for a long time.

Mr. Grundy's improvement continues. We have watched with interest his daily walks around Waste Court Field; and, to judge from the local press, the Councillor has returned to the Council Chamber with renewed vigour.

We congratulate Mr. and Mrs. Willis on the birth of a second son, Richard Guy, on 23rd February.

At Easter we said goodbye with regret to Miss Shedden, who had been Matron at Larkhill since September, 1949. She will be much missed, both in the sick-room and behind the Larkhill footlights; and in thanking her for all she has done for the School we offer her our very best wishes for the future.

During the past term we welcomed three students in training, two from Oxford, Mr. Barthorpe (French) and Mr. Hillam (English), and one from Cambridge, Mr. Evans (Classics). Mr. Evans, like Mr.

Rattee (whom we were glad to see recently in the guise of a visiting lecturer) was a resident; so we had more opportunity of getting to know him. To all three we offer our thanks for their services and our good wishes for the future.

At the beginning of the Lent term the number of boys on the School Roll was 381 (Dayboys 244, School House 84, Wastecourt 34, Larkhill 19).

We congratulate C. S. Wiggins on his election to the Abingdon Scholarship (in Mathematics) at Pembroke College, Oxford; also Neil Purnell on the award of a Berkshire Major Scholarship (tenable at Downing College, Cambridge). Congratulations also go to the members of the Leach clan who are going to Confuse the Issue at Sandhurst. B. W. T. Leech has already reached the R.M.A. through the ranks; H. R. Leach has successfully surmounted R.C.B. and will join his near-namesake in June. We hope that M. J. Hudson, who has passed the written papers of the Sandhurst examination, will be following them later in the year.

Congratulations too to M. J. Brackley and B. D. Guimaraens who, having satisfactorily completed a fortnight's training, are now enrolled as Marines in the R.M.F.V.R. Their Marine uniforms will make Corps parades seem even more amphibious.

The School offers its thanks to Dr. O'Connor, who instigated the return to the School of a beautiful edition of the Latin Corpus, once presented as a School prize; and to Mrs. Brown, of Didcot, for the presentation of a vast and comely family Bible for lectern use. Acknowledgment should also be made of two unusual items of anonymous public service. Let us then thank the boy who has so beautifully executed the historical note now displayed in the Science Block; and the small team who made themselves responsible for the care of the School flag during the recent period of national mourning. Only those who have themselves tried to handle the flag in a strong wind will realise what a delicate operation it is.

After the dry and sunny days of early March, the weather treated us maliciously on Sports Day, but it was not quite as inclement as last year, and we were able, as later pages will show, to carry through the programme.

The germs too held their hand until the end of term. One Sunday in February every single boarder was on parade for Chapel—a phenomenon remarkable even in terms alleged to be more healthy. But later we too were smitten by influenza, though not so ruthlessly as most schools. And the last laggard invalid was able to go home on Easter Eve.

Mr. Hugh Lyon, Director of the Public Schools' Appointments Bureau, talked to Senior members of the School on 24th March. Afterwards he interviewed boys who wished to discuss their careers with him.

Parents of boys in the Sixth and Fifth Forms were entertained at a Parents' Evening on 12th March.

We were especially indebted to Mr. Squiers who came down to lecture at very short notice: the original speaker, Lt.-Col. J. H. Williams, was unable to come, and Mr. Russell Brandon succumbed to influenza after we had obtained his services.

A technical hitch delayed the showing of this last film for nearly two hours, and consequently most dayboys were unable to see it. In recompense, a special programme was shown on 27th March, the main film being, "The Clouded Yellow".

The fugitives from the examination by the Regional Mass-Radiography Unit held last term were finally examined at Reading on 4th February.

A party of boys attended the Abingdon Drama Club's production of "Victoria Regina" at the Corn Exchange on 12th February; the Fifth Forms attended a production of "Macbeth" by the Hertford College Dramatic Society on 25th February; and on 5th March, the School was well represented at a performance of "Richard III" by the Oxford University Dramatic Society at the Playhouse, Oxford.

On 28th February, a meeting of the South Midland Branch of the Science Masters' Association and A.W.S.T. was held in the Science Block, attended by about twenty members. The laboratories and parts of the School were inspected, and members were entertained to tea and a lecture.

A small party from School was present at a lecture organised by the Friends of Abingdon and given by Miss A. C. Baker entitled "Christ's Hospital 1553—1953". The lecture took place on 20th March in the Council Chamber.

Wednesday, 25th March, marked a milestone in the history of the School, when the embryonic School String Orchestra gave its first ensemble performance, if that is the right word, to a small but select audience. We congratulate Mrs. Kitching and Mrs. Fry on the progress which they have already made with their violin and 'cello classes respectively.

The activities of the Camera Club continue to entertain and amuse us. The film camera has followed the Headmaster into the Heylyn Room and the Chaplain into the Chapel. Life will certainly be more dull when "Operation Hollywood" is completed. Advance extracts of the film that we have seen have been (dare we say surprisingly?) effective and interesting.

The approach of the Coronation has revived interest in the Abingdon bun-throwing; and the Reading Mercury has recently referred to the two historic specimens (one thrown at the Diamond Jubilee, one at the Coronation of King Edward VII) which were formerly kept in a glass case at the School. They bore the teeth-marks, or so it alleged, "of an over-zealous youth whose efforts they resisted round about 1927". At a rather later date they seem to have vanished from human ken.. possibly into an even more zealous, or more voracious, youth?

THE CORONATION

Primarily, the School will celebrate Coronation in absentia; for there will be an extended half term to enable boys either to go up to London or at any rate to be with their parents on the actual day. School will end at 12.30 p.m. on Friday, 29th May. Boarders will return to their houses not later than 7 p.m. on Thursday, 4th June, ready for School at 9 a.m. on the Friday.

But those of us who are left will make as brave a show as we can. To decorate the whole building adequately would be scarcely practicable; so apart from flying the School flag we shall concentrate on the Science Block, which will lend itself to the display of dominion flags and coronation emblems. "Dress rehearsals" are taking place during the holidays. And we shall be able to find a quorum to represent us at such traditional ceremonies as the bun-throwing.

Subsequently too the School will be producing at least one historical episode in the Schools Pageant, apart from helping in other ways.

The question of individual souvenirs is still being considered by the Corporation. We shall have our own permanent souvenirs of this historic event in two teak seats, suitably inscribed, which the Governors have agreed to provide for use in the School grounds.

It may be added that to remind boys that the Coronation is something more than pageantry and junketting, arrangements are being made for every boy in the School to see beforehand a special film of the last Coronation Service.

WORKS AND BUILDINGS

(a note by the Headmaster)

We are still waiting for the licences for the new washing-up pantry, but we hope we shall get them in time to undertake this major work of reconstruction during the Summer holidays. Meanwhile we record our thanks to our good friend Mr. Wiggins who has made a beautifulnew 'high table' for the Dining Hall. Visitors find it difficult to believe that the solid oak of this table came mainly from the overmantel in Lacies Court displaced by the Mayott fireplace.

We are reaping the benefit of all the painstaking now preparatory work that was put in on the War Memorial Field, for the grass is coming up commendably clean. The site for the main entrance from the Faringdon Road, which will be through a pair of wrought iron gates, has already been marked. During the Summer we hope to get the fencing up around the three open sides of the field. It has been decided to plant a line of fastigiate hornbeam along the northern edge, to screen the new houses to the north without masking our immediate neighbours.

There is good news of No. 21 Park Crescent. Thanks to the helpful co-operation of the Borough Council, we can now look forward to taking possession before the end of May. This will enable us to push on with the work of repair and adaptation: and if all goes well the School will return in September to find Mr. and Mrs. Talbot ensconced therein with some sixteen boarders. It is no easy task starting a new boarding house in these days, especially one that will have to feed itself, and I am sure we shall all wish Mr. and Mrs. Talbot well as they face As the house will also contain two small their new commitment. senior classrooms we shall have to plan the time-table carefully to avoid too many cross-country journeys between No. 21 and Lacies Court. In the matter of names, unless or until something better is suggested we shall refer to the new house as Crescent House. This name has the merit of being short, descriptive, unmistakable and reasonably euphonious: it has the negative advantage of avoiding an invidious selection of one from our many benefactors. 'House Full' notices, by the way, are already up, though only metaphorically.

And now for a new building venture. The present 'Pavilion' (to use a courtesy title) is neither ornamental nor adequate for our needs. strong committee has therefore been set up, representing the Governors, the Old Boys, and the Staff, to consider the possibility of replacing it with something more in keeping. It is hoped that the major portion of the cost can be covered by the balance of the War Memorial Fund and that the O.A. Trust Fund will be able to bridge what gap remains. The cardinal problem is one of site, for the trouble of having a school that nicely bisects its own grounds is that no pavilion can possibly cover all the playing fields. After long consideration of all alternatives it does seem that the immediate solution is to build a simple pavilion more on less on the site of the existing building. This would still leave it open for us to move the First Eleven Pitch to the War Memorial Field at some future date; in this case the 1953 pavilion would become the Second Eleven Pavilion, and we should have to build another pavilion on the new field—as indeed we shall have to some day, in any event.

To design such a pavilion so that it does not spoil the facade of the School will present the architects with a very pretty problem. Meanwhile we can say that the Committee has already had one very profitable meeting (on Maundy Thursday); and we can offer our very warm thanks to Mr. Fiori and his assistants who produced an admirable model of a suggested pavilion which has at any rate provided a point d'appui for discussion.

THE BOARDERS' CONCERT

The concert was held on the last evening of term in the Gymnasium, where a temporary but spacious stage had been erected. In spite of difficulties in presentation in the Gym, the production compared very favourably with those of former years.

During the first half of the Concert, music was provided by the Brass Band, with a solid and satisfactory performance of the march "When Jesus Comes", and by the Dance Band Quartet with a medley of popular tunes. Those experienced trumpeters, Leach and Redknap, gave us the duet "Bonne Bouche" by Waldteuffel, and Mr. Cooper sang "Come ye not from Newcastle?" while the Choir gave an excellent rendering of Orlando Gibbon's "Silver Swan". Two short sketches were ably performed by members of Middle School, and finally Williams H. G. and Amey presented an old favourite under a new name, "The Recess in the High Street".

After the interval, the Headmaster in Barkeresque garb expelled one by one the members of the Staff Choir for their inability to follow his conducting in a silent rendering of "Clementine", but Mr. Burgess and Packer restored sobriety with "Variations on a Theme of Hadyn" by Brahms. "Other Times Other Manners' showed us just how different courtship was one hundred years ago, and "The Dentist's Chair" supplied some real old-fashioned melodrama—murders, ghosts and repentant wives—perhaps not the ideal theme for such a concert, but well acted, nevertheless. The Prefects' Choir burst momentarily into song with "Doctor Foster", and the entertainment was concluded by the Choir in a rousing chorus extracted from "The Sorcerer" by Mr. Barker.

It was apparent from the first how much hard work had gone into this production; each sketch was well executed, and not once was anyone at a loss for his lines. Players, producer, and stage-hands alike are to be congratulated for their varying contributions to a most enjoyable evening. And a special word for the stage-hands; their unseen efficiency was manifest in the smooth flow of the whole production. We have it, too, on good authority, that they got up at five o'clock the next morning in order to clear the gymnasium.

CHAPEL NOTES

Memorial Service to Mr. Etty

Morning Service on Sunday, 18th January, took the form of a memorial service to the late Mr. John Lyttleton Etty, M.A., J.P., a Governor of the School, whose death occurred during the previous month. Representatives of the many public bodies with which Mr. Etty had been associated joined with the School in commemorating his long life of service. The Lessons were read by the Chairman of the Governors (Admiral F. Clifton-Brown) and the Mayor (Ald. H. G. Mullard), and an address was given by the Headmaster.

Others present, apart from members of the family and personal friends, included the Town Clerk, the Master of Christ's Hospital, the Chairman of the Borough Bench, the President of the Old Abingdonian Club, and representatives of the Abingdon Musical Society, the Friends of Abingdon, and Ruskin College.

The unsightly pitch-pine benches, which disfigured the centre aisle, have now been replaced by the new oak joint stools. These arrived shortly before the end of term and they tone in extremely well with the remainder of the Chapel and add much to its beauty. We are most grateful to the Trustees of the War Memorial Appeal for agreeing to defray the cost from the balance of the Fund, and to Wing Commander Viney (O.A.), of the firm of Messrs. Vineys, for the great personal interest he has taken in their design and manufacture. It is pleasant to think that these benches have been designed and executed by a local firm.

The first consignment of the new kneelers has also arrived and these too are most satisfactory. Only the stalls have been fitted out with them at present but it is proposed to purchase more in small batches, until there is one for everybody. We are extremely grateful to the anonymous donor who has offered to assist financially in this matter.

Visitors to the Chapel may have noticed a damp patch on the ceiling in the N.W. corner. This is due to a split in the lead lining of the roof, which has now been repaired. However, re-decoration of this portion of the ceiling will only take place when it is quite certain that no further leak is possible.

A minor improvement to the Chapel is the provision of red warning lights outside the main doors and the door of the organ loft, to indicate that a service is in progress. This should do much to lessen external distraction.

FAURE'S REQUIEM

A performance of Fauré's Requiem was given by the School Choir in St. Helen's Church on the last Saturday evening of term, 28th March, and was attended by a large number of parents and friends of the School. This was the Choir's first real public performance and was therefore a great step forward in its continued progress under the direction of Mr. Barker. The soloists were D. S. Lloyd (baritone), D. J. Meakins and M. Q. King (treble), and the Choir was accompanied by R. E. J. Packer, who played with the skill and feeling of one several times his age.

The Choir commenced by singing "Let Thy merciful ears O Lord", an anthem by Thomas Weelkes, brief but pleasing. Then followed the Requiem which was excellently performed from the first crashing chords to the final breath of sound dying away into nothingness. During an interval, passages from Bunyan's "Pilgrim's Progress" and "The Holy Sonnets' of Donne, both admirably suited to the performance, were read from the back of the Church.

One half of the retiring collection was given to St. Helen's Church and the remainder went towards the (necessarily heavy) cost of the music. We are very grateful to the Vicar of Abingdon and to the organist of St. Helen's, Mr. Hugh Fowler, for allowing us the use of the Church and the organ for this performance.

TUCKSHOP NOTES

At may be of interest to Old Boys to learn of the extent to which the tuckshop has recovered from the lean war years. In new premises—the old C.C.F. clothing store near the north-east corner of the gymnasium—a flourishing trade is carried on. The more popular lines include buns, sweets, "pop", potato crisps and ice-cream, while pens, pencils, protractors and even pocket handkerchiefs are also available.

Some may wonder what happens to the profits. It will be of interest to both past and present to learn that the cost of the new School Flag was borne by the Tuckshop, as also was half the cost of the new edition of Chambers Encyclopaedia for the Library. There is also an annual contribution to the printing expenses of The Abingdonian, and a helping hand has been extended from time to time to such worthy causes as the preservation of the Roysse Archway and the Literary Magazine. In all about £100 has been put to good use in the past two or three years, while a reserve fund is being gradually built up in the Trustee Savings Bank.

The moving of Brackley from back to inside forward immediately increased the effectiveness of the forward-line which soon settled down to a well-balanced combination.



REVIEW

100 BEST POEMS IN THE ENGLISH LANGUAGE, Chosen by Stephen Graham. (Ernest Benn Ltd. 10/6).

He is a brave man who attempts to select the best poems of our language. The best, mark you, not just one hundred good poems. It is not to be expected that such an athology will meet with whole-hearted approval, for each of us will note omissions of seemingly obvious choices.

Mr. Graham emphasises that the production of an exclusive anthology is something that is very unusual and perhaps he felt some trepidation when he wrote, "It is a personal choice of the hundred best poems in the language." Certainly he admits that he was anxious for his omissions, in particular of Shakespeare's work. This, I think, argues that he had some doubts in his own mind over his choice. In any anthology claiming to contain the hundred best poems, to allot only four of those to Shakespeare must lead to apalling omissions. Only two of his Sonnets are included, when at least twenty are worthy, and we find not one of the songs from the plays, nor one of his other poems.

I cannot honestly believe that Thackeray's "At the Church Gate"—which is a composition designed to show the minor talents of Pendennis—deserves anything more than Thackeray's own, "I think they'll do". So with many other poems in this collection. They will do, but they are certainly not great.

If Mr. Graham's book is to achieve anything approaching the authority of such anthologies as those of Palgrave and Quiller-Couch, he must seriously reconsider his choice of such poems as Browning's "Evelyn Hope", which I was particularly sorry to find in these pages, as it represents a weak and maudlin Browning; "The Raven" which only

lives because of a certain felicity of metre; "A Psalm of Life", which Mr. Graham cannot really expect us to take seriously; and "The Diverting History of John Gilpin". Instead, he should seriously consider the claim of the Augustans, very poorly represented here as it is. And it is high time that Pope was given his rightful place.

I think that Mr. Graham was dominated by the feeling that the poems that he learnt in the classroom must at all costs be included, and in an attempt to balance this he made some rather unusual choices. But the general state of this anthology is sound. There are, however, some sickly plants, some overgrown blooms, which should not have been allowed to mar the beauty of this gathering.

Finally, in the next edition, let the title be changed, for in order to avoid the charge of presumptuousness, the personal element should from the first be made plain.

LONDON DINNER

The first post-war London Dinner of the Old Abingdonian Club was held at the Holborn Restaurant on the evening of Monday, 9th March. Cobban, and a strong contingent from Abingdon, including six past and present members of the Staff.

After the loyal toast, which was given musical honours, the company drank to the health of "absent friends" with especial reference to Mr. Grundy. The President then proposed the health of the School with which he coupled the name of the Headmaster. He expressed his pleasure that the dinner had been revived and that so many Old Boys had been able to attend it, and he mentioned the many messages of greeting and good wishes that he had received from others.

The Headmaster in reply congratulated the President on being a member of the Governing Body and gave a report on the recent progress of the school. Mr. Duxbury in proposing the toast of the Club pointed out that the Club was first founded in 1743 and that by a happy coincidence the first London Dinner of the revived Club had taken place in the same Restaurant sixty years ago. Wood, a past President of the Club and a Governor of the School, who entertained the members with reminiscences of the successful rugger team which was run by the London Old Boys before the war.
