EDITORIAL

In the course of his speech at Prize-Giving, Mr. Peterson referred to the snobbish attitude of many people who speak about 'the barbarian scientists'; at the risk of sticking my neck out I should like to consider the possibility that there might, after all, be a grain of truth in that phrase. Before I go on, however, let me say straightway that the majority of the scientists whom I have met have been extremely human and civilised, and no doubt most other people would say the same; this leads to what I would call a dangerous generalisation, that all scientists are nice, sensible people and that as long as our future is in their hands we have nothing to fear.

Members of the Headmaster's scholarship set will be quick to spot the fallacy in this argument, for 'the scientists whom I and most other people have met' are by no means the same as 'all scientists'. At the CACTM Schoolboys' Conference in Oxford last April, those present heard Dr. G. W. Series speak on 'Christianity in an Age of Science', a talk in which he particularly stressed the danger of the scientist, boxed up alone in his laboratory, treating people as things, as human units in a Plan, and not as fellow-beings. It is this, the boffin-type scientist, who, I feel, might merit the epithet 'barbarian'.

Some time ago, when the Russians had just launched Sputnik number one, Mr. Nehru expressed his consternation that technical progress was so far outstripping civilisation; while, on the one hand, the scientists were promoting such harmless (perhaps even beneficial) ventures as the projecting of satellites into space, on the other, they were still party to an absurd and vicious armaments race which could only be brought to an end by multilateral renunciation of nuclear weapons (I would not suggest for a moment that Britain should lead the way in disarmament for that would be to sign her own death warrant). The Internationa Geophysical Year was an example of what 'human scientists' can do towards world peace, but such enlightened projects are more than cancelled out by continued tests of the latest weapons devised by the 'barbarians', whose existence seems to be bounded by formulae and totally alienated from human nature.

In Ancient Rome the emperor used sometimes to find it advisable to banish philosophers, astrologers, magicians and the like from the city i their ideas and prognostications seemed detrimental to his regime. Ever if it were practicable to banish the boffins, it would not be a course advocated by me; however, what I do suggest is firstly that the budding scientists in the School should not take themselves too seriously (certain non-scientists might well take a step in the other direction!), and secondly that the 'barbarians' should be let out of their laboratorie from time to time and given an opportunity to breathe the Strontium 90 and gambol in the radioactive rain and feel that it's good to be alive

We look forward very much to having him as our Vicar and we hope that during his ministry the relations between Parish Church and School Chapel will become even more close and happy.

Mr. Dixon was formally instituted as Vicar of Abingdon with Shippon and Rector of St. Nicolas by the Lord Bishop of Oxford on the evening of 14th September. The Headmaster and Mrs. Cobban and two senior prefects represented the School.

We congratulate Mr. and Mrs. Hillary on the birth of a son, Andrew Guy; and Mr. Phizackerley and Miss Baker on their engagement, which was officially announced on 22nd July.

It is with particular pleasure that we have just heard of the birth of a son to Mr. and Mrs. Helliwell, at Rugby (9th September).

This term we say good-bye to Mr. Pole, who is leaving to take up a business appointment where his interest in the communication of ideas will stand him in good stead; and also to Mr. Prosser who has stood in for Mr. Mark Williams for one year while awaiting a vacancy at Cuddesdon. To both, our warm thanks and good wishes.

We look forward to welcoming back to the fold Mr. Mark Williams, after his ordination at Michaelmas. Mr. Williams will serve his title at Dorchester so he will lead a busy double life.

We shall also welcome two new masters, Mr. P. F. Emms and Mr. M. R. Stevens. Mr. Emms, an Open Scholar of Magdalen College, Oxford, has just taken his Final Honours Schools in French and German. During his national service in the R.A.F. he successfully

THE SCHOOL PROPERTY — AND OTHER MATTERS

(A note by the Headmaster)

There is still much to be done in the last fortnight before the School re-assembles. But if all goes well the boarders of School House will return to find themselves provided with adequate changing-rooms and drying-rooms and plenty of showers, and with a first-class reading room. Two hide settees, the first instalment of the new furniture, arrived today and are now in situ, swathed in dust-sheets, while the decorators work around them. Study Corridor already presents a New Look, with its light walls and many-coloured doors. End Study has also been completely redecorated. In the new block proper there is a large new dormitory (as yet unnamed) and two ranges of basins and sanitary accommodation (one on each floor). The School Prefects will at last have a room consonant with their dignity. And-a sign of the times this-a telephone booth is all ready for equipment by the G.P.O. The architects and the builders have done a fine job of work. We are grateful to them, and also to Messrs. Millard of Basingstoke, who have gone to endless trouble over the provision of suitable furniture. It has been a great help to us to have this side of the business handled by someone who as a former head of School and School House can speak with authority of consumer requirements.

Now that the new wing is almost completed the Governors have been able to push ahead with their next project, which will take the form of a single-story block of four class-rooms, extending eastwards from the entrance hall of the Teaching Block across the old tennis court, with a slight curve to the north. We hope that work on the site will start in the late autumn. The Governors have also approved of two further projects—a block of four houses for staff to be erected to the north of Glyndowr, fronting on to the Faringdon Road, and a proper School Shop, to the north of the Jekyll Garden, which will replace the existing Tuck-Shop-and not before time! The class-rooms and the School Shop will form part of one integrated plan, and the architects have laid them out in such a way that they may some day be joined together by a further three-story block running (if we remember our compass aright) from N.N.W. to S.S.E. Although contemporary in design and construction it is hoped that they will enhance rather than diminish the amenity of Lacies Court. Indeed, that has been one of the main considerations of the architects throughout; and speaking for myself I am pretty sure that the lengthy conferences and the abortive draft plans which have taken up so much of our time during the last year will prove in the event to have been well worth while. The "artist's impression" of the new Shop, reproduced in this magazine, will give some idea of what the architects have in mind. It will be very exciting to see their ideas given material form in the next year or two.

The class-rooms and the Staff houses will be built from School funds. The Governors have decided that the 'Shop' shall be the first-fruits of the Quatercentenary Appeal. Its erection will not in any way prejudice the primary objective of the Appeal, which remains the conversion of Big School into a new Library. But this is the kind of job which calls for very careful planning and in any case it cannot be put in hand until we have the new class-rooms available to replace Big School.

It is now common knowledge that we shall shortly be changing over to the Oxford and Cambridge Joint Examinations Board. There are sound educational reasons for this transfer, though it is with mixed feelings that we say good-bye to our friends of the Oxford Delegacy with whom our relations have always been—and still are—of the friendliest. But we shall have to do rather better at 'A' level than we did this year. Perhaps our present drive to raise standards of achievement all round will soon begin to show results. Certainly the marks at 'O' level were much more encouraging. It was particularly pleasant to find boys in the 'C' stream getting up to six passes. And of course Keith Haarhoff deserves especial congratulations on winning a State Scholarship at an almost indecently early age.

Again this term I have found amusement and pleasure in the varied literature which has been produced unofficially in the School. My warm thanks to the Editors of Gryphon, 1-X Times and the Model Boat Club Magazine who have so punctiliously fed me with complimentary copies. I think I have identified Grahamstein and Timbolonski, whose rich and original vein of humour shows no sign of exhaustion. Some day perhaps they will find an opportunity for their satire in the pages of the Abingdonian. Presumably because of the distractions of the examination, Octopus has appeared rather less regularly this term. Whether it will survive the departure of its main-if not its onlie-begetter, I do not know. If it does not, then the Editorial on the 'Freedom of the Press' which appeared in the Founder's Day issue (no. 25) forms a fitting valedictory. At its best (and it is by its best that I shall remember it) 'Octopus' reached a higher standard than any other unofficial school newspaper that I have known. I shall miss its pungent editorials—and Uncle Roger's Korner too. The enterprise of the Editors in providing an 'Octopus' Rest Room on Founder's Day was appreciated by many foot-sore and weary visitors.

Now for the Literary Magazine, which for obvious reasons the Editors of the Abingdonian cannot say much about. I thought the general standard was good. The prose contributions, including some from Lower School, were straightforward and muscular. Andrew Millard's verses again indicated real creative imagination. The Editor's contributions in his own name did not perhaps show him at his best. I should have liked to have seen again his prize-winning poem on

'Dreams' to compare it with Peter Wintle's and John Sheard's, both printed herein. Of the two, I think the latter just had the edge on P.W.'s. I have two general criticisms—one of them very minor. It is a good thing that such a symposium should be representative of the whole school; but one might have expected rather more contributions from the sixth-form English specialists. And while the Editor this year overcame his coyness so far as to publish a table of contents it would have been helpful if the authors' names too had appeared in it. Congratulations to all concerned—not least to the Printer who produced, as always, a fine piece of work, at a time when things must have been very difficult for him.

THE QUATERCENTENARY APPEAL

By Founder's Day the Appeal Secretary's calculations were able to assure us that we had just reached a total of £21,000. That is a very gratifying achievement for the first year—but it still leaves a terrifying gap for us to bridge before 1963. We have to remember too that on the one hand only some £6,000 of this total is in hard cash: and conversely that if we want to have any buildings ready for opening in 1963 we shall have to start building them—and start paying for them—long before that date. Indeed the Governors very much hope that the new school shop will be constructed within the next two years: and that the swimming bath and the reconstruction of Big School will follow as soon as possible. That is why we do beg any parent, Old Boy, or 'plain friend' of the School who is still just thinking about the Appeal to translate his good will into action as soon as possible.

As a matter of interest, this total of £21,169 is made up as follows:

Single donations £4,112

Covenanted subscriptions (including estimated repayment of income-tax £6,052) ... £16,643

Other annual subscriptions ... £414

A fourth list of subscribers follows. To all of them, our very warm thanks—as too to the many parents who responded (to the extent in all of £248) to our ploy with the bills last term. EXAMINATION RESULTS

Results at the 'Advanced' Level of the recent General Certificate Examinations, which are appended, were disappointing. The number of subject-passes (84) fell below last year's record total and a number of boys who ought to have got distinctions just failed to do so. Congratulations however to K. N. Haarhoff on the award of a State Scholarship—so soon after his sixteenth birthday!

Conversely the 'Ordinary' Level results were, over-all, much more pleasing, and promise well for the future. The number of subject-passes, some 520, was about 135 in excess of last year's figure, itself a record. It is true that some part of this increase is due to the new organisation of the middle-school curriculum which enables intelligent boys to clear certain subjects at an earlier stage, so that in effect our successes are this year spread over more than one age-group and are to some extent gained at the expense of the future. There was also rather less 'by-passing' than in previous years. When all allowance is made for these two factors however there still remain grounds for modest satisfaction, in spite of the inevitable disappointment over certain individuals.

We were all deeply grieved to hear of the sudden death of Dick Comben. The first part of the funeral service was held in the School Chapel, which he had looked after so well, on Friday, 12th June. We shall always remember him for his gentle, kindly ways and his cheerful willingness, and we offer our sincere sympathy to Mrs. Comben and all his family in their grievous bereavement.

At Morning Service on Sunday, 3rd May, the Chaplain dedicated the new hymn-boards presented by his friends in memory of Rupert Sladden. We were very glad to welcome Mr. and Mrs. Sladden and Rupert's two brothers to this service. Later in the term, on Old Boys' Sunday (14th June), came another dedication, of the simple bronze tablet which the Old Boys have had installed in the Chapel in memory of that very great gentleman Bill Bevir.

Despite a small attendance (perhaps the imminence of the examinations had something to do with this), the Chapel Council held a lively meeting at Lacies Court on Thursday, 25th June. The Chapel Council can play an important part in that it provides the Chapel Committee with an opportunity to report on its activities and also gives the ordinary boy a chance to express his feelings and ideas regarding the Chapel and the School services. One topic which did arise this time was what the School should do to help in World Refugee Year. This is under consideration and we hope some definite policy will be decided before next term.

The Headmaster will be preaching at the School service in St. Helen's on the first day of the Michaelmas Term. Last Term we experimented by seating the choir in the choir stalls. This greatly improved the singing and the responses and at last we think we can say that we have reached the best solution of this particular problem.

With the new oak pews the East end of the Chapel is beginning to look very lovely and the Chapel Committee is now seriously thinking of a fitted carpet for the apse, which might subsequently be continued down the aisle. But first we must complete the establishment of proper kneelers—a less exciting but very necessary project.

FOUNDER'S DAY

Were the School insured against wet Founder's Days, the insurance companies would have accumulated a fat profit over the years, and would no doubt have gazed in a contented way at the brazen skies which favoured us once again on Saturday, 25th July. Although the timetable was slightly (and successfully) altered the day's bill of fare remained the same. First there was the service at St. Helen's Church, where we were fortunate to secure as our preacher Bishop Allen, formerly Principal of Ripon Hall and now Bishop of Derby. He based his sermon on two texts-one the well-known "Crabbed Age and Youth", and the other from the 1st Epistle General of St. John, Chap. II v. 14: "I have written unto you fathers, because ye have known him that is from the beginning. I have written unto you, young men, because you are strong, and the word of God abideth in you, and ye have overcome the wicked one." His theme was the relationship between youth and age, between vigour and more mature experience; this was the problem of the age, he said, and inferred that, in the case of those to whom St. John was writing, the partnership was a successful one. The answer lay in "him that is from the beginning", "the word", a fellowship in Christ where youth and age freely lent their vigour and experience to one another.

In the afternoon the Prize-Giving was held in the Corn Exchange; for the decorations we once again thank a willing band of helpers under Mrs. Willis. Afterwards Mr. and Mrs. Cobban were "at home" on Upper Field to the accompaniment of the Brass Band and (for the first time)

with the assistance of outside caterers. In addition to the multifarious exhibitions, two literary creations were on sale, while a third was advertised. Once again too we were treated to a new film by A.S.P.S.—"Three's a Crowd"—which was supported by John Becker's delightful colour film of Abingdon "This is Your Town", made last year for the Civic Trust. Special mention may be made of the "Rest Room" in the New Teaching Block sponsored and tastefully furnished by the Editors of "Octopus"," which offered a welcome haven for those exhausted by the "arduous training" course provided by the other exhibitions.

"An Evening Entertainment", of which a critique appears elsewhere in this magazine, rounded off a very successful day.

On the evening of Sunday the 26th, the Headmaster preached at the statutory service in St. Nicolas' Church. On such an occasion, he said, one's dominant thought was the fact that many boys were about to leave the School for the last time. The end of a boy's school career he described as "a milestone that comes in a pretty tricky turn of the road", but he pointed out that just as most roads were little different each side of a milestone, so the movement of the adolescent from boyhood to manhood was 'not a sudden transition, it's a continuous process." Juvenile delinquency and the instinct to revolt against "the establishment" were nothing new, and things which most people grew out of. The danger today was not the "Teddy boy", but the highlypolished, self-sufficient young man who thinks he knows all the answers. He hoped that those who left the school would not be standard Public School products, but people with a sense of humour and initiative, which he described as "the urge to strike out for yourself." Above all, however, he stressed the necessity of "personal integrity" which had as its basic ideals the teaching of Christ-"the compass which will guide you through the turbulent waters of adolescence."

PRIZE-GIVING

The accent this year was on brevity and much mirth was caused on and off the platform by the ostentatious self-discipline employed by the speakers in limiting their time; moreover a welcome break in tradition came with the lapse of the "cheers" which have always made people a bit self-conscious in the past.

The Chairman of the Governors, Mr. C. G. Stow, opened the proceedings by welcoming the parents to the prize-giving, and then called upon the Headmaster to present his (curtailed) report.

In his speech the Headmaster welcomed the Mayor and the new Borough members of the governing body; and then proceeded to fill the unforgiving twenty minutes with as much wit and information as anyone could wish for. He reviewed the athletic and academic achievements of the year; and went on to say that every effort would be made in the coming year to raise the intellectual standard of the School, and in connection with this the School would be changing over to the Oxford and Cambridge Joint Board for the G.C.E., which would offer a more stimulating challenge to boys. He then recalled some of the events of the year he remembered most vividly. He spoke of the state of the Appeal Fund and said how touched he was by the generous response from parents, but there was still a long way to go before the target was reached. He outlined the recent and future developments of the School, stressing the potentialities and advantages that a direct grant school such as Abingdon possessed. He concluded his speech by expressing his thanks to the Governors for all their understanding and support, and to all those who had helped him throughout the year.

Mr. Stow then welcomed Mr. A. D. C. Peterson, O.B.E., M.A., the Director of the Oxford University Department of Education, and asked him to present the prizes.

When he had distributed the prizes, Mr. Peterson congratulated the prizewinners and asked the Headmaster if the boys could bear to leave their work for an extra half-day in their honour. He expressed his pleasure at being asked to present the prizes and then went on to say a few words on education. He said how vitally important it was that we should take education more seriously and, even if the politicians would not take the initiative, we ourselves should do all in our power to support our schools and ensure for our children a good, balanced education. He pointed out the dangers of specialisation at too early an age and stressed the necessity for co-operation with the universities to secure a broad education for the young people of today. Speaking to the prizewinners, he said that it was primarily for them to plan their education and to keep alive as many interests as possible, and to break down the barriers between Arts and Science.

Mr. Stow then thanked Mr. Peterson and the proceedings ended with the singing of the National Anthem.

AN EVENING ENTERTAINMENT

In place of the light operas of the last two years, a return was made this summer to the Evening Entertainment. Performances were put on on both the Friday and the Founder's Day evenings. We are grateful to Mr. Griffin, chief producer, to Mr. Sawbridge, musical director, and to those ladies of the staff who not only helped so much in the training of the choir and the orchestra but also took their places as leading members of the orchestra on the evenings concerned. Our thanks too go to Dr. E. G. Phillips, a parent, to whom we are indebted for the critique of the entertainment which appears below—

"The news had leaked out that this was to be an entertainment in a wider and older sense than that word has come to carry in these days. The first piece was a delightful example of the expectations I had built on this report. Here were all the musical instruments that the boys have learnt to play for their own pleasure skilfully arranged into a small orchestra; recorders strengthening the solitary oboe, a tuba discreetly hidden behind the solitary bass, giving to it a strange warm depth, and of course a plentiful spread of the more orthodox components. This is certainly how Handel's music was made at the time of its composition and it is still, I think, the most enjoyable way of hearing it.

The next few items were a complete surprise. Or rather, we were amazed and the dead languages were surprised in the act of living again. Through the mouths of A. G. D. Matson and I. A. D. Martin, Latin came, shall I say, about half alive, rumbling, pedestrian, rather stiff in the joints and needing also occasional jabs of the prompter's needle. Greek, which followed, had the advantage of a better scenario and in the piece spoken and neatly acted by T. A. Libby, R. S. Ogg and I. M. Cunningham I enjoyed every gesture and was only disappointed by the absence of sub-titles. The speech from the Iliad by R. S. Green which followed was again not so effective. The majority of the audience were recalled to their barbarian status and to us it sounded like well read verse rather than spoken poetry.

Entertainment proper was resumed by a return to music. D. Wiggins brought a lovely tone out of his 'cello but he became rather flustered by the difficulty of the piece and towards the end one wished he had chosen something less ambitious. This irritating criticism must also be levelled at J. H. Thewlis in the Flute Concerto. For most of the time it was completely enjoyable but Mozart, the naughty fellow, had to go and put in certain very awkward bits which were not so much played as overcome.

For the last item before the interval we returned to the dead languages—this time it was literary Irish. Fortunately our culture was broad enough and we (I am speaking for the audience) found little difficulty in understanding the drift of the play. In fact we not only understood, we enjoyed it very much indeed, rather in mood of those who are at last beginning to find what they had sought. The four actors, J. S. Kelly, R. T. Moll, N. P. Loukes and the one playing the fowl (his name was not given in the programme) were all excellent and hit off exactly the right tone of domestic entertainment.

I am sure that everyone enjoyed A. P. Haynes' solo trombone and the band and I was sorry that the Shah of Persia was not with us. I mean the one who, after a concert in England, said that the thing he had liked best was the man who kept on swallowing yards of gas pipe.

After this rousing interlude there was a modest return to the Third Programme. I was a little disappointed in G. A. Hall's speaking of the Ronsard Sonnet. He has a beautiful French accent but he could not resist the temptation of speaking as fast as he could. It was too fast for the audience. The other two, J. R. N. Ogle and G. M. Morse, spoke with more feeling and it was at this point only in the whole evening that to me at least the spirit of poetry was truly present.

The German frolic brought us back to reality. We were being amused again. With its sly dialogue, its fun and games, and its genuine homemade originality it was easily the high-water mark of the evening's pleasure. It will go on living in the audience's memory when much of the rest has been forgotten and this is a good thing for it will make them want to come again next year.

Meanwhile the Reeves House Quartet—A. G. Fairlie, J. Fairlie, N. P. Loukes and A. P. H. Wood—soon captured us with their delightful singing, well balanced and clear in tone.

The next items were satisfying to me intellectually for they solved a problem which has often puzzled me, viz.: what are these jingles by our tone-deaf poets for. This combination of chorus, relay and singles which trundled the rhythm along was obviously being enjoyed by the performers and the fact that we could not make out much of what was being said was a decided help. E. C. R. Evans and A. L. Howell tried an interesting experiment with voice and guitar.

The finale took up again the theme of the overture. All hands on deck with singers as well in a remarkably well scored arrangement of the Polovtsian dances from Prince Igor. The singers were a little coy at first but soon the whole thing was vibrating with musical energy. I enjoyed it hugely at the time and looking back I can only marvel at the courage of Mr. Sawbridge in undertaking it and praise the skill and enthusiasm shown by all those taking part."

CRICKET

FIRST ELEVEN

An XI which begins the season with only three of the previous year's side may well expect to have a lean year, and for this reason, if for no other, 1959 deserves to rank as a very successful season. Morris, Ford and Perry were the survivors, with Baldwin, a most successful 2nd XI bowler in 1958, to back them. Practically all the other members of the side came straight up from the Colts XI, and it says much for their spirit that they were able to cope so well with the very different conditions prevailing in senior cricket.

D. G. Morris proved to be a successful captain in many ways, as the cheerful spirit of the team bears witness, and it was good to see the habit of holding a fielding practice before every game continued. His great fault however lay in field-placing, and in keeping control of the game. He handled his players admirably, but there were too many cases of gaps in the field remaining unplugged, and of missed tactical opportunities. This, after all though, is the most difficult aspect of a highly complicated game and no Captain ever goes unscathed when the critics set to work. On the whole he is to be congratulated, as are his team for their loyalty, and his personal success after a bad start was all the more welcome for this.

The bowling always looked like being a problem, and we did very well to bowl out so many sides. The regular bowlers were P. J. Ford, Long, Whitton, Baldwin and Goodwin. Ford was potentially the best of the openers, though still amazingly erratic at times, and should be a tower of strength next year. He is really fast, and moves the ball both in the air and off the pitch, and the fact that he only took 15 wickets for 20 runs apiece is not a true indication of his ability. Evans began the season well, but was replaced half way through the season by Long, who made good use of his height and shows promise of developing into an intelligent and effective medium-pacer. Whitton, who confounded all the critics against the City of Oxford School, bowls with great heart and stamina, but has a faulty action with which he is still struggling. He has taken criticism in the right spirit and could well become the most effective of the quicker bowlers. The slow bowling was monopolised by Baldwin and Goodwin, who often proved too powerful a combination for the opposition. Baldwin's left-arm spin, with cleverly varied flight and pace, though he is still sometimes prone to bowling down the leg side, accounted for 26 wickets at a cost of 14 runs each. Goodwin's slow off-spinners, well-flighted, usually of impeccable length, and with more than usual turn off the wicket, accounted for 34 wickets at 13 runs each. Baldwin will be missed next year, and it may not be easy to find an adequate substitute, but Goodwin remains to tease many an opponent into indiscretion. Undoubtedly their best performance together was against the Berkshire Gentlemen when between them they took the last seven wickets for a cost of 15 runs.

Probably our biggest anxiety was the batting, and in the early practice games it appeared likely that we should be lucky to reach three figures on many occasions. However, in the event, it was very adequate, sometimes excellent. Reluctance to punish the bad ball all too often made our rate of scoring slow, though there were occasions when the necessary runs came quickly. Inexperience was largely to blame, and with eight of this year's young side remaining the prospects for next year are much higher. Towards the end of the season several players were proving that concentration and willingness to think in terms of a long innings were paying dividends. The captain, D. G. Morris, settled after an uneasy start and carried off the batting honours with 337 runs and a batting

average of just over 30. He recognised his limitations and made full use of his strokes. His defence was suspect, but concentration and determination saved him on many occasions. Probably the most improved young batsman was Bunce who as a fifteen-year-old showed great promise and scored 250 runs at an average of 19. A left-handed opening bat, he developed in the course of the season most of the scoring strokes to add to a sound defence. Next year should see the fruits of much hard work both by Bunce and Mr. Smithson. Goodwin, the other opening bat, made 254 runs at an average of 18, and though unorthodox he made good use of his leg side scoring strokes and began to show marked improvement in defence. His running between the wickets was particularly good. P. E. Perry played two or three good innings but never really settled to run-making as a habit. He hit the ball hard, but was too often out seeking to play a straight ball to leg. He could well become the mainstay of the side next year, but will have to concentrate on each individual innings and cut out the fatal sweep. Of the other batsmen, Hamilton, Nurton, Whitton and Utin have all played their part on occasions, and Ford and Long have proved that they can make runs when required.

Generally speaking the fielding has been good this season, throwing in being particularly accurate, though there have been some surprising lapses. The outstanding fielder was Utin at cover, who proved himself indefatigable and ubiquitous. It was a joy to see his keenness and accurate throwing. Whitton and Goodwin took some fine catches, and Hamilton proved himself a very safe outfielder with a good throw. Nurton's wicket-keeping, though polished in appearance, suffered from two big faults. He takes his eye off the ball too often, and he does not stay down for long enough. He could make an unusually good keeper, but he will have to concentrate on these failings.

We look forward to next season with pleasant anticipation. If the general enthusiasm and progress of individual players are maintained it could be a very good side. There are likely to be more players knocking for admission to the team than there are vacancies and this is always a healthy state of affairs. The chief problem is likely to be another slow bowler, though there are several possible candidates. No report would be complete without a word of gratitude to Mr. Smithson for his hard work and invaluable advice. His share in the development of these young cricketers cannot be over-emphasised.

SECOND ELEVEN

In terms of results this season's 2nd XI did not live up to expectations. While the bowlers of the side steadily improved and frequently did more than was expected of them on the hard wickets, too often was it left to them to hold up the batting as time and again the "recognised" batsmen failed to fulfil the promise of earlier years.

Yarkoff did all a captain could with characteristic thoughtfulness and zeal. Only in the matter of winning the toss was he unable to have his own way being successful only twice. Perhaps, then, the season will best be remembered for hot toiling in the field where Burton's work behind the stumps was better than anything produced by an opposing side. His was an example of concentration all too rarely followed by the slips, a fact which blunted a lively attack by Long, Robey and Yarkoff. With Long's commendable transfer to the 1st XI much of the sting went out of the attack: Evans, D. R. M., replaced him and though capable of steady spells did little to trouble most batsmen. A more desirable result of Long's departure was the obvious stimulation to the efforts of others to win a bowling place in the side. Of special note was the progress made by Bampton, R. J. C., whose 15 for 104 in 40 overs was good enough to suggest that, with his excellent out-fielding and throwing, the future is bright. The fielding was on the whole satisfactory though the hard grounds made ground fielding difficult.

It took some time for the batting order to sort itself out. Eventually Burton emerged as one who could give his side many a sound opening achieved, in the absence of strokes, by first-rate calling and running. With his partner, Hossent, this attacking opening was always heartening to watch. Hossent's own contributions, the products of eye and courage, improved as the season grew older and led to a memorable opening first wicket partnership of 102 in the final match of the season.

Of the rest of the side no-one was consistent enough to give the team—or the captain—much confidence. Each had his moments and the improvement of Carslaw and Robey was pleasing. Robey's 37 against Abingdon C.C., from an exhibition of free-flowing driving, left one in no doubt that he was potentially a very promising all-rounder.

The fielding also varied between very good and rather slack. Runs which might have changed the result of a match were sometimes given away needlessly. Throwing in was a general weakness, several of the team having strong throws, but being unable to control them.

Ogg was a very good captain, calm and authoritative, and his own performances both with bat and ball were an example to his side.

The Junior XI played as a team and had a very successful season under a good captain, Bailey (G. J.), Chadwick and Barrett (A. 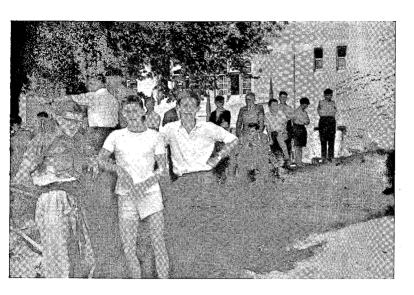

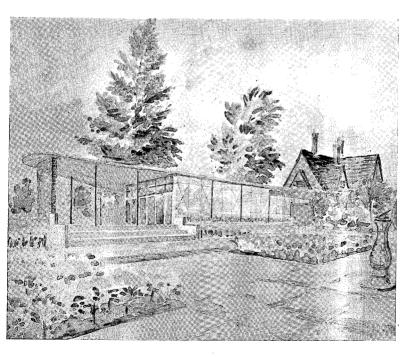

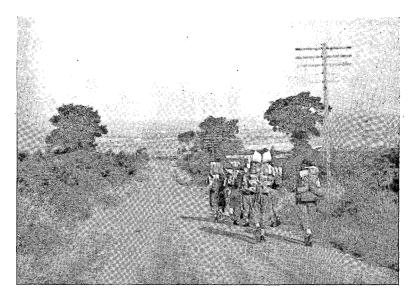

ANNUAL CAMP: WESTDOWN, TILSHEAD

A self-help overflow Camp—this was the official description of Tilshead Camp, a home for contingents prevented from attending at their original place of parade. This label conjured up visions of rough conditions and sketchy administration—visions which we imagine accounted for our having only 42 cadets, the smallest contingent we have taken to Camp since the immediate post-war years.

A pleasant surprise was in store. Accommodation and feeding (again this year on civilian contract) compared favourably with those at the Depot of the Devons where originally we had been going. Admin.—admittedly easy to handle in a camp of only 700 cadets—was smooth, unobtrusive and free from all forms of fatigues by cadets. In fact, the only fly—wasp rather!—in the ointment was (from a C.O.'s point of view at any rate) the Training Officer, a volcanic, much decorated survivor of the Imjin River, whose conferences—held daily during the first half of the Camp—consumed much time while generating great heat and almost equal confusion. Frustrating at the time but amusing enough now to look back upon . . .

Demonstrations were a feature of the training; so much so, indeed, that the time actually spent on Field training was only just greater than that allotted to demonstrations and range work. All the advertised demonstrations took place, in the sense that cadets duly reported to the R.V. given; unfortunately, one—the parachute drop—failed to take place (as it nearly always does!) and a film had to be shown instead, to spectators who had travelled some distance in coaches for the demonstrations were effective and effectively run. The camp was sited halfway between the Schools of Infantry and Artillery—which geographical fact accounted for the comparative glut of 'show-business'. It was not so much a question of laying on expensive shows specially for the cadets as of taking them to see things which were being done in any case. It would be ungracious and silly of us to complain about this lavishness when we recall how thin and uncertain demonstrations in full scale camps have tended to be in recent years.

Field training took the form of a number of patrol exercises, all of which were carried through with dash and a commendable degree of efficiency. ARDUOUS TRAINING

Under a new scheme authorised by the War Office a party of eight senior boys led by Mr. Montague was enabled to go on a pretty tough trek through Wales instead of attending a more orthodox camp. The party was entirely self-contained and lived off packed army rations supplied by Southern Command. The members of the party were as follows: R. J. C. Bampton, R. W. J. Bampton, T. J. Barrett, A. J. Costley, D. G. Morris, R. S. B. Shepard, T. A. Sewry and P. P. Wintle.

An account of the journey by one of the survivors is appended.
"Having left Abingdon at 9.40 a.m. on the last day of term we travelled by train to Llanelly, arriving at 3.40 p.m. From there we marched 2\frac{3}{8} miles to Cwm Bâch where we spent the night in a stone

floored barn. Although it rained in the night the morning turned out clear and in fact not a drop of rain touched us the whole time.

On Wednesday morning we were on the road at 8 a.m.; immediately we were confronted by our first big hill; hereafter every step was either up or down hill! It is surprising to note that everyone preferred to go up hill rather than down—it was easier on the blisters. These in fact affected all but one member. We walked fifty-five minutes in the hour and tried to do most of our mileage in the morning only doing about $2\frac{1}{2}$ hours in the afternoon.

Passing through Kidwelly we arrived at Ferryside at lunchtime. On the map Ferryside is shown to operate a ferry. At Kidwelly we had been informed that it was unlikely to be running. When we got there initiative was called for, it turned up in the form of two boys who borrowed an outboard motor and took us across in an old ship's life-boat. The opposite side was too shallow to allow us to step on to dry ground and so with well over 50 lbs. on our backs and boots in hand we did a 'beach landing' much to the amazement of some local inhabitants. After lunch we were off again and made Ebenezer where we were put up by a very friendly farmer, Mr. Lewis. He gave us a small cow shed with fresh straw laid for us; this was our most comfortable night after travelling $14\frac{3}{8}$ miles.

Friday found us passing through Mydrim and on to Boneath where we spent the night in a disused stable. On this journey we went over some very bad hills but covered 19½ miles. This was our hardest day. The first few days were passed in quiet thought but now we burst forth into song, we went through the Public Schools' Hymn Book, the hit parade and all the songs of the 1920's—in all of these ably led by Lt. Montague.

From Boneath we went on through Cardigan and down to the coast, a mere 75 miles. Here we were offered a small disused chalet looking over a valley and the river Afontifi. After lunch everyone converged on the salt water and paddled their feet, then relaxed for a day's rest. Socks were washed and some even allowed themselves a clean set of clothing. Incidentally we all remarked how friendly the Welsh were; everyone we met on the road said 'Goodmorning' to us, to which we replied in the native tongue (we could manage six phrases in all).

On Saturday morning as a treat we were allowed an extra hour in bed (if that is what you can call a wooden floor) rising at 7 a.m. The morning was spent preparing for an early start in the afternoon. At 5 p.m. we reached Cwn Cych a total of 12 miles. The night was spent in a lush green field beside a stream.

Dawn came bringing Sunday a day of rest—in which we covered 17g weary miles. On through Carmarthen in mid afternoon stopping for the night in an old goods wagon which had been used as a hen house.

Bank Holiday Monday saw us on the main road to Pontardulais being passed by coach after coach of people going to the beach at Tenby. Covering 15 miles we passed through Pontardulais and stopped at Pont Lliw, where we were offered the use of an old house. We all spent a good night and were eager to cover the 6 miles to Swansea, our destination.

We sighted the sea at 10 a.m. from a hill, for the last time the agonizing cry of "Packs on" was heard and we descended to the beach where we decided to spend the night.

The afternoon was spent in swimming, sunbathing, and sleeping. After our evening meal, which was watched with curiosity by several people, we dug ourselves in for the night.

Up at 5 a.m., we marched to the station and returned weary but full of high spirits to Radley where the Headmaster and Major Parker met us. To show that we were not as dead as we looked we marched the 2½ miles to School and after being well fed, jumped joyfully into hot baths."

Dowson, Piano (Merit); Grade III—J. Fairlie, 'Cello; R. A. Hall, Violin; P. P. Hutchinson, Violin; R. J. Parsons, Violin; J. D. Urwick, Piano; Grade II—M. A. Faires, Piano; F. R. Howlett, 'Cello (Merit) and Piano; J. D. Sabel, Violin; P. A. Wedgwood, Piano; Grade I—R. D. Booker, Piano (Distinction); G. H. Hallett, Piano (Merit).

The greatest achievement, however, was gained by D. Wiggins who, having already gained a Distinction in Grade VIII 'Cello, was awarded one of the six Scholarships given each year by the Royal Schools of Music. He will be studying at the Royal Scottish Academy. There are very few boys who can claim four hours' practising a day: he can—and this success is the result of hard work and keenness.

The Band performed as usual on the Empire Youth Sunday Parade on 10th May, and members of the Senior Orchestra and Choral Society joined in the Schools' Festival in the Corn Exchange on 14th May. This was a performance of Handel's "Saul"—to commemorate the bicentenary of his death—organised and conducted by Mrs. Kitching, to whom both the School and the Town owe so much.

Members of the Senior Orchestra recorded the music for the Unicorn Theatre's production of "The Tempest" at the end of May and on the 31st May we had an admirable Recital by the Berkshire Wind Trio. The Heylyn Room was packed, and we were treated to a varied fare—pieces by Mozart, Arrieu and Boyce, and less serious ones by Bonneau and de Haan: with Variations on 'Charlie is my darling' for Bassoon and Piano to round off the evening.

The House Music Shield was won by Blacknall for the third year running, but Reeves won both the Orchestra and the Singing Cups. Other results: Solo Singing—Unbroken Voices: S. A. J. Richardson (Tesdale); Broken Voices—J. H. Thewlis (Blacknall). The standard of both playing and singing showed signs of improvement on last year, and we are most grateful to Mr. D. A. H. Youngman, Director of Music at Monkton Combe, for his helpful advice and criticism. He had a good sense of humour, and always put his finger on the right thing—whether fir ling a fault or commending something. Blacknall owe their continued success to Thewlis and Wiggins—both of whom are leaving—and Reeves had excellent leaders in G. S. Howlett and Loukes.

The Chapel Choir joined some six other school choirs in singing evensong in Winchester Cathedral on 9th June, under the auspices of the R.S.C.M. This was a most worthwhile occasion, and everyone learnt something from it—and the singing was of a high standard.

Dr. John Varley visited us once again, and his programme included the "Moonlight" Sonata, Chopin's Scherzo in B flat minor and Brahm's Sonata in F minor. This last is a work of some 25 minutes, and it is a tribute to Dr. Varley that the audience was 'hypnotized' from the start. His annual visit gives us all great pleasure.

Ogle, Llewellyn, Redgrave and T. H. Day were trumpeters in the St. Helen's School performances of Britten's "Noye's Fludde"—a most ambitious and successful enterprise. The Band played competently on the Inspection of the C.C.F.—and was commended by the Inspecting Officer on two marches—both of the Royal Artillery: his own Regiment.

For their Swan Song, Thewlis and Wiggins arranged a most successful Concert on 19th July, with music for Horn (R. G. M. Johnston), Trombone (A. P. Haynes—also composer); Violins (A. J. Williams and E. C. R. Evans)—with themselves providing Flute, Piano and 'Cello! They were both soloists (as was Haynes) in the Evening Entertainment, a critique of which appears elsewhere.

It would be wrong to conclude an article without paying tribute to these two, who have done so much to make music mean something in the School. Thewlis is a versatile organist, pianist, flautist and bass, and Wiggins an outstanding 'cellist. These are merits enough by themselves, but it is their musicianship and keenness that have shone through everything they have done here, and they will be greatly missed. One will remain an amateur musician, the other will become a professional: but wherever they are destined to go, they will always be welcome and assets to any society. Let younger musicians follow in their footsteps.

The first season of Subscription Concerts will start next Term. The membership is limited to 100 at present—divided between Town & Gown—and the response has been most encouraging. The Concerts for the first year will be held in the Heylyn Room and in Chapel.

EDINBURGH FESTIVAL, 1959

4th September.

A visit to the Vienna of the North is not inappropriate to some who were in the Austrian Capital in April. Fine weather, glorious views, friendly people and first-rate performances make a Festival. Scotland can justly be proud that she houses one of the finest Arts Festivals in the world.

There are twelve of us from Abingdon here, and in ten days we are attending twenty-five events. This may appear to be an over-subscribed programme, but the fare is varied, and one is able to enjoy to the full each and every performance. A few examples of the events we have attended may help to show how broad-minded the organisers are in the Festival.

By far the most accomplished orchestra we have heard is that of the London Mozart Players. They number 25 at full strength, and are all soloists in their own right. Maxwell Ward plays viola with them, and we had a most enjoyable "reminiscing" evening with him after one of their Concerts, at the Festival Club. It seems a long time since he taught at the School in 1955, but he recalled happy memories of his time there. We also met Archie Camden in the Club, surely one of the greatest bassoon players: those who heard him in 1956 in Abingdon, will want to hear him again in the Abingdon Music Society Concert in December. The Mozart Players were at their best under Rudolf Kempe, who is due to be a second Toscanini. Their playing is masterly, and they are all so relaxed; all aspiring musicians could watch them to advantage.

The Scottish National Orchestra is much improved under Alexander Gibson, the first Scottish conductor they have had. At their Concert

we met Mr. Peter Percival, now teaching in Liverpool, and Mr. Donald Anderson, who taught for a term in Abingdon—and who showed immense courage in overcoming his disabilities. We were more than happy to meet his fiancée.

We have also met Mr. Robert Ponsonby, who directs the Festival. He will be renewing his acquaintance with the School at the House Music in October. The Finnish Ballet, in Britain for the first time, employ both the Bolshoi and Royal Ballet techniques, but their productions are too monotonous, despite lively casts and a large competent orchestra. They are at their best in dances of their own Country.

The Czech Art Exhibition is disappointing, due probably to too much influence from other countries on their painting. Rampal and Lacroix are brilliant musicians. They played four of the Bach Flute and Harpsichord Sonatas to a capacity audience, and we were very fortunate in sitting in the front row. Rampal's tone is outstanding, and his breath-control is to be envied by any woodwind player. To hear music on disc or tape is pleasant enough, but one sometimes yearns for the bygone days when there were no mechanical aids, and concert-going and music-making were more widespread in our homes. I recommend only one thing in this note—to all interested in Music; "go and see what you wish to listen to." The reward will come, and may lead to active rather than passive music in the end.

The Oxford Theatre Group provide a first-rate late (10.45) Revue—"Better Never"—which is so good as to warrant a visit to London next month. Elspeth Douglas Reid is a Scottish Ruth Draper, and a real actress. These last two shows are 'Fringe' Entertainments, not organised by the Festival, but worth recognition by Patrons since they show amateurs at their very best.

Being twelve in number, we usually have a row in each theatre or hall. The party is not unwieldly, and there is ample spare time for small groups to go sight-seeing and to pursue their own interests. The weather has been glorious—no rain—and has shown Edinburgh at its best. Our last event will be the Tattoo, which surely epitomizes all that is Scottish, in the true setting—the Castle Esplanade. Edinburgh is a friendly city, and aspiring visitors will not find their time or funds mis-spent. Why not forego the next seaside holiday, and enjoy to the full the 1960 Edinburgh Festival?

AFTER EXAMS ARE OVER . .

We had no big Excursion Day as such this year, but School Societies which wanted to organise rather special outings were encouraged to do so on Tuesday, 21st July, so as to minimise the dislocation of ordinary routine. In addition two series of 'initiative tests' were organised. The first, or 'high-level', one involved taking eight senior boys out by car,

blindfolded, on the evening of 20th July. They were dumped in pairs just before midnight along the western edge of the Cotswolds and were left holding a map and instructions to make their way on foot to Burford, some fifteen or twenty miles away, as quickly as possible, and thence to return to Abingdon by public transport. At least one intermediate 'point' was inserted to draw them away from the main roads. In fact the night was so brilliantly clear, with a full moon, that all the four pairs were very quickly able to orientate themselves and find their position, and what was intended to be an initiative test became mainly a night trek across some of the loveliest country in England. Well before mid-day on the Tuesday all the participants had reported back to School, and each party submitted a very commendable log before turning in.

Then on the morning of the 21st all members of Form 5.C were taken out by coach and dropped in pairs along the road from Newbury to Highworth (B. 4000). The idea was to race back to School under their own power; and again some attempt to control the route and equalise the difficulties was made by the insertion of 'points' (e.g. "find out en route the time of the last collection from the post-box at East Ginge"). This proved a surprisingly successful expedition; the winners were M. K. Henson and M. D. T. Nash who reported home in less than five hours after being dropped.

Our real problem this year however (a problem which incidentally will not arise in the future when we have changed our examination board) was again to find some entertaining and worthwhile interest in life for the boy-and particularly the boy who was leaving-who had finished G.C.E. and who was not deeply committed in the preparations for Corps Inspection or Founder's Day. It was with him in mind that we devised a "Project System". Boys, individually or in syndicate, were given full scope to pursue an approved project which might be anything worth-while from the construction of a three-dimensional map of Arran (the Skye Group did this and did it very well) to a thesis on local ghost stories, a survey of the church organs of North Berkshire, or a series of photographs of vintage traction engines. The attraction of the scheme was in its simplicity. Boys could work on their project, by leave of their form-master, at any time that they were not wanted for any other School activity. Many of the results, as displayed on Founder's Day, gave evidence of considerable and careful research. It was extremely difficult to pick out the prize-winners. Eventually six projects were selected as being prize-worthy, others were 'highly commended'. Perhaps the two best were A. A. Venn's solo effort on Abingdon Abbey and the survey of local bridges by D. R. Gerring and J. V. Comfort. In addition a special prize was awarded to T. J. Barrett for his work during the last fortnight of term on the School Films. Altogether one gathered the impression that the Project System had been thoroughly well worth-while.

ROYSSE SOCIETY

For the first meeting of the term the Headmaster kindly invited the Society to attend a performance of "Ruddigore" at the New Theatre in Oxford. Not many of us had seen this opera before, and we found that, although unlike any other Gilbert and Sullivan work, it provided very good entertainment. On our return to school we were entertained with a wonderful salad and plenty of fresh fruit, prepared by a few of the School House prefects, which brought the enjoyable evening to a fine close.

At the second meeting we heard a specialised paper read by a scientist: P. J. Ford's paper had the impressive title "Beyond Materialism—a Study of the Human Brain", and in it he dealt with learning during the period of childhood, behaviour patterns, memory and the conscience. Discussions started off quietly around these topics, but inevitably the questions of the human soul and the existence of a god cropped up, and the argument that ensued was extremely lively.

The last meeting of the term and year saw the exploration of completely new territory, with A. J. Foden reading a paper on "Advertising." An examination of the motives behind the advertising in oligopoly, monopoly and castel formed the basis of this well-informed paper, with references to television and subliminal advertising included. Discussion was extremely relevant, and centred chiefly around the reader's conclusion that the greatest service of advertising to mankind was that it enabled mass-production to develop so prosperously.

That the meetings over the past year have been so enjoyable is largely due to the continued hospitality of the Headmaster and Mrs. Cobban, to whom we extend our thanks.

At the Society's first meeting of the term Dr. M. A. C. Heavens (O.A.) gave a talk entitled 'Machines in Medicine'. This was a most interesting talk, which was mainly concerned with the heart-lung machine.

At the next meeting J. H. Thewlis lectured on 'The Earth in Space and Time'. He started off by talking about the three main theories of the formation of the Universe and then moved on to the formation of the Earth. The facts and figures he brought in, which seemed incredible to many of those present, helped to make this a most enjoyable talk. At the last meeting of the term another lecture was given, this time by R. F. Jackson, Esq., on 'Some principles of Engineering'. This talk was accompanied by several experiments on the strength of variously shaped model girders. This talk aroused the interest of everyone present and was indeed a most enjoyable lecture.

PHOTOGRAPHIC SOCIETY

This year has seen the production of our first film with a properly synchonised sound-track, and this has been our main activity. The film, "Three's a Crowd", was adapted from Chaucer's "The Pardoner's Tale" by Mr. Pole and set in present-day surroundings. The three young men who go to seek for Death in a fit of revenge find him eventually, not under a tree as in the original tale, but in a deserted house.

The unusual properties for the film included a large American car, a flick-knife, a guitar, a bottle of 'poison', and about fifty pounds in cash, so the reader will be able to surmise for himself our modern equivalents

of the kind of characters Chaucer had in mind.

Technically, if not artistically, the film is our greatest achievement to date. The method of 'sound-tracking' the film had to be seen to be

believed, and involved fourteen people—four tape-recorder operators, four live-effects men, a projectionist, and five actors—all working to a split second schedule exactly in time with the projected picture, projected, incidentally on to two screens at once! Now we are beginning to tackle much wider range of types of picture in the future.

Lastly, we should like to express our grateful thanks once again to all those who helped us in the production of the film: to the School for its new projector which made the whole film possible, and to the owners and proprietors of houses, cars, chemists' shops, coffee-bars, tape recorders, etc., for their kindness (and patience!) in letting us use their property—thank you!

THE FORUM

Although the Summer Term is longer than the other two terms it is also more crowded as far as out-of-school activities are concerned. As a result we have held only two meetings of the Society this term. Both took the usual form of discussion on a wide range of topics.

At the first we talked about Liberace v. Cassandra and educational technique at great length, without reaching any definite conclusions, and with many comments on both subjects which would have provided Cassandra with plenty of material for an attack on the public school.

At the second meeting we covered more ground, speaking at length about the effects of television, money spent on medical research and

the life of a public school boy.

The standard of discussion at both these meetings has been high, and it is clear that some boys are gaining great benefit from this. But attendance at meetings has not been as encouraging as it might have been, and the present secretary hopes that his disappearance from the scene will be the sign for bigger and better attendances at meetings.

- Richard Brown was the eldest of four brothers who were at the School at the turn of century. He left fairly young and spent some

years farming in Canada before returning to this country. Stephen was Captain of the School in 1897, Captain of the Cricket XI, in which he played for five seasons and was in the Soccer XI for three seasons. He went up to Keble College and gained his Soccer Colours there. George was also a good athlete, went up to Selwyn College, Cambridge, and was Secretary of Boats. The youngest, Arthur Anthony (1900–05) was Captain of Soccer and went to Caius College, Cambridge. After taking his degree he went to Ceylon tea-planting. He served in the Royal Artillery in World War I as Captain, was awarded the M.C. and was killed shortly before the Armistice.

Roger Haywood was a School Prefect and rowed in the 2nd IV. He was commissioned in the Royal Berks Regt. in 1914 and taken prisoner in 1916. After the war he went to Calcutta to a firm of exchange-brokers and remained there for most of his life. In 1942 he was a member of the Bengal Legislative Assembly.

Francis Robinson was the youngest of three sons of the Vicar of Drayton who were at the School. He left early when his father moved, and later went up to St. Catherine's Society, Oxford, and was Captain of Boats. Subsequently he became an accountant. His brother William Edward (1880–87) also went to St. Catherine's and gained his Trials Cap in '88 and '89. When he went on to Guy's Hospital he joined the London Rowing Club and rowed in their Grand VIII in '91 and '93. He qualified as a doctor in 1897 and in 1906 took his M.D. degree at Oxford. He practiced in London, and in 1905 was President of the O.A. Club. The third brother Frederick George (1882–87) was apprenticed to Elder Dempster and later transferred to the Union Castle Line. He reached the rank of 2nd officer of the Dunmolly Castle and died at sea in 1903.

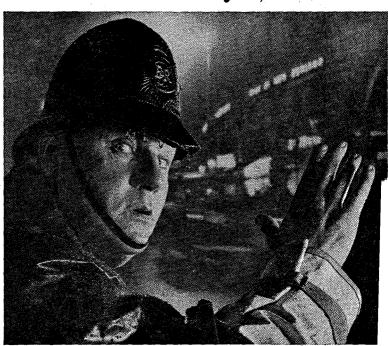
