EDITORIAL

At a time when there seems to be a mania for remembering people and events of the past, two anniversaries this year have been considered so important that our half-term holiday this term is to be extended by a day in celebration. It is worthy of note that the Magna Carta of 1215 and Simon de Montfort's summoning of Parliament in 1265 should be recognised in this way, while the Battle of Waterloo is not. This difference is a very important one, and something that we should bear in mind. The defeat of Napoleon and the threat to Europe that he represented have long been of no immediate relevance to the people of this country, whereas the ideas that have sprung from these two revolts against the authority of thirteenth century English Kings have played an important part in our history, and are very much with us today.

In the case of Parliament, this is not hard to see. After defeating his King in battle, Simon de Montfort summoned the burgesses of certain towns to join the barons, prelates and knights of the shire in a Parliament, in order to give himself broader support in the country. This was not especially significant in itself, but it did provide a precedent for the future and a basis for the development of the House of Commons. Thus, in remembering 1265, we are remembering the early stages of an institution that was eventually to provide the government for this country and to be a model for half the world.

Magna Carta is something much less tangible and seemingly more remote. Again the product of a rebellion, it was concerned with the practical problems of the barons of the day, and its only sanction was military force. It was resurrected by the antiquarian lawyers and Members of Parliament of the seventeenth century, who saw it as a precedent for the assertion of their own rights in a struggle with another King. It did not in fact lay down any theories of human rights, and yet it has come to be a symbol of liberty and freedom in Britain and America.

This holiday, therefore, is an occasion for us at School to think a little more carefully about the individual rights and liberties, and the collective responsibility for the government of our country, that will soon be ours. It is also a chance to consider what is really significant among the innumerable events, opinions and forecasts that we have thrust upon us by the mass media of today. Magna Carta and Parliament of seven centuries ago represent in a very real sense what Western civilization is trying to maintain in the twentieth century. We should recognise them as some of the most deep-rooted parts of our heritage not lightly to be forgotten.

SCHOOL NOTES

Those of us who remember the gay aplomb with which the Speaker presented the prizes in 1961 will wish to join in sympathetic good wishes to Lady Hylton-Foster.

The Headmaster represented the School at the united funeral service for the members of the R.A.F. who lost their lives in the recent disaster, which was held at St. Helen's Church on 12th July.

We tender our sympathy to the Misses Morland on the death of their mother, after a long and wearisome illness. Mrs. Morland, whose late husband, one of eight brothers educated at the School, was for many years Clerk to the Governors, retained her own interest in the School almost to the end. Several bachelor masters and boys who have been boarded out at Trampletts in recent years will cherish grateful memory of the kindly hospitality of the Morland family. A Requiem Mass was held at S. Michael's Church on the morning of 5th August. There will be a memorial service on 27th September.

We have been saddened to hear recently of the deaths of two young Old Boys as a result of road accidents. Michael Dicker (1954) was killed on 18th June, and Peter Mildenhall, who left only three years ago, died on 12th August as a result of a collision the previous day. To the families of both we offer our profound sympathy.

As too to Mr. and Mrs. Mobbs, formerly of Whitefield. The fact that we had seen their son John so recently when he was home on furlough made the news of his death out in Kuala Lumpur, on 4th July, as the result of a racing accident, even more tragic. His memorial service in Chapel is reported elsewhere.

To Alderman Mrs. Cox, who has now completed her three-year stint as a representative of the Corporation on the Governing Body, we offer our warm thanks for all that she has done for the School in that time; and we welcome in her stead Councillor Aubrey Smart who as a parent has already shown his deep interest in us.

We congratulate our Chairman, Mr. Stow, on his election for a second term of office as a member of the Committee of the Governing Bodies Association; Alderman Freeman, on his re-election as Chairman of the Wallingford Rural District Council; and Professor Cormack on his appointment to the Chair of Greek at Aberdeen. But we are sorry that this appointment must mean that Professor Cormack severs his official connection with the School that he has served so well since his appointment in 1957 as the first representative of Reading University on the Governing Body.

Staff changes this term are so numerous as to call for a special article. The various presentations that were made at the end of the term showed how much the School appreciated the devoted services of Mr. Murray and Mr. Booth. Mr. Carey and Mr. Foley have only been with

us for a short time but we are equally sorry to say good-bye to them. To all four, our very best wishes — good wishes which extend too to Mrs. Murray and to Mrs. Booth.

We are very grateful to Mrs. Sackett, Mr. Martin, Mr. Butt and Mr. Alan Harrison who between them have this term been covering the double vacancy in the Physics Department; and to Mr. Reynolds who helped to stand in for Mr. Tammadge during the second half of the term.

On 8th May we welcomed the Headmaster home from his tour of Persia, replete with carpets and anecdote. At the end of term School House said farewell to him after fifty-five terms as its house master.

Mr. Tammadge left for his lecture-tour in America in mid-June. Shortly after the end of the term Mr. Tyson followed the general direction of his foot-steps by flying to Trinidad in order to expound the mysteries of the New Mathematics to three successive training-courses.

We offer our warm good wishes to Mr. Owen on his marriage, on 7th August, to Marion Turrell; and to Mr. Cullen on his engagement to Miss Mary Randolph, sister of our own Mr. Randolph.

All these changes have of course led to internal adjustment. Mr. Potter is taking over from Mr. Murray as house-tutor in charge of Heylyns. The Headmaster will have a dozen senior boys, just not prefects or house-prefects, with him at Lacies Court. Mr. and Mrs. Tammadge face the formidable job of running School House and of feeding three other houses as well. Mr. Payne, one of our new masters, will be the resident house-tutor of School House, and he will have Mr. Cullen and Mr. Lewis to help him, while Mr. Truran, another new master, will be house-tutor over at Lacies Court.

We congratulate Mr. and Mr. Sewry on becoming the first staff grandparents, by the birth, on 15th August, to the wife of Trevor Sewry (OA) of a daughter, Nichola Jane.

We are very grateful to Mrs. Duffield, of Chieveley, who has kindly offered to endow an annual prize for local history. This area is so rich in memorials of the past that there is an unusual scope for study of this kind; and this prize should provide the necessary impetus.

Our warm thanks too to Mr. Hyde-Parker for a gift of curious and useful scientific apparatus.


We are indebted to Mr. Eric Stitcher, M.B.E., J.P., for a most valuable addition to our archives — an autograph letter of the Duke of Wellington, written on 25th March, 1837, in his capacity as Chancellor of the University, to the then Headmaster of the School, the Rev. J. Hewlett, 'acknowledging a complaint which had been made by the School against Pembroke College' (we quote from the catalogue description). Mr. Stitcher has added to his kindness by having this letter suitably framed for exhibition in the Grundy Library.

We have not had quite as many visits as usual from overseas this

term. But on 20th May we welcomed Commander Firoz Shah, Director of Naval Education of Pakistan, who was visiting English schools prior to taking over as Principal of the Petaro Cadet College; and (on the same day) Canon Martin, Headmaster of S. Alban's School, Washington, and therefore former headmaster of Richard Van Wagenen. Then on 13th July we had the pleasure of entertaining a strong party of American teachers in course at Oxford.

It is interesting to note that of the four principal authors of the long-heralded Book One of the Schools Mathematics Project, two — Mr. Tammadge and Mr. Tyson — are 'ours'. We welcome also, with appreciation if not yet with complete understanding, Mr. Tammadge's first individual publication, a book on 'Complex Numbers' published by Blackwells.

Congratulations too to Michael Liversidge on his admirable little pamphlet on the Decorated Ceiling in St. Helen's Church (some day this will be listed among his 'Early Printed Works'). We note also



that two Old Boys have appeared in print recently. Roger Green has had a third article 'On an Athenian Roof-Top' in Cornhill and Richard Lucas is part-author of an article on his adventures in Voluntary Service in New Guinea, 'A World of Difference', published in the Lancet of 24th July.

The radio critic of the Sunday Telegraph said on 16th May, in reference to the magazine programme 'This Time of Day' that 'if there was one single item which did most to put the programme's name on the map, it was probably the Highway Code sung as an Anglican psalm by a quartet of schoolmasters from Abingdon.' Inspired by success,

Messrs. Horrex, Pratt, Keating, Montague and Cullen foregathered again at Lacies Court during August to put on tape, with the help of Malcolm Johnston, some further musical frolics which we may expect to hear on the radio before long.

And we hear on good authority that E.M.I. are producing a disc of the 'Highway Code'; and that the Quartet may also appear on the next disc of Peter Sellers.

On the subject of electronics, those who look in at the ATV programme 'Temptations to Loyalty' on October 20th will find that some part of it was taken against the background of Lacies Court, which the Unit visited on 8th September. Perhaps we had better explain that the programme is about Dr. Fuchs, not our Headmaster.

The number of boys on the School Roll in April, 1965, was 585, of whom 193 were boarders.

Foundation Scholarships were awarded this year to C. J. Nicholl (of Holme Grange School, Wokingham) and D. W. Galbraith (of Abingdon School); and Exhibitions to C. McI. King (of Holme Grange School) and P. J. Shaw (of New College School). It is a coincidence — and a happy one — that both Nicholl and King are 'younger brothers'.

We congratulate D. J. Munson and D. W. Penney on the award of Flying Scholarships: and M. F. Wells on becoming a Queen's Scout.

Two Parents' Evenings were held in the Court Room this term, one for the Sixth Forms on 4th June and one for the Fourth Forms on 18th June.

Mr. G. K. Barnes visited the School on 4th June on behalf of the Public Schools Appointments Bureau: and on 8th July two local Welfare Officers gave a talk to the Third Forms on the work of the Welfare Service and the opportunities which remain for private enterprise to fill the gaps in it.

Many thanks too to Professor M. H. Hull (father of J.M.H.) who talked to a rapt audience of sixth-formers on 26th July about American Universities.

A strong contingent of the C.C.F. paraded for the opening of the new T.A. Centre on 9th May. Inspection Day followed on 28th May, when we were visited by Air Commodore L. H. Greenman, with supporting officers of the three services.

On 2nd May the three School Orchestras combined to give an informal concert in the Court Room. Later a series of recitals was arranged by Mr. Billington in St. Helen's Church after Evensong on four successive Sundays, in which several members of the School took part. Mr. Cullen and G. H. Hallett gave organ recitals and A. G. Fairlie, A. R. Gibbs, G. H. Hallett and F. R. Howlett played various instruments.

R. P. Jessett and D. W. Tanner ventured as far north as Leeds for a two-day conference for sixth-formers organised by the University on 8th/9th July. Other outside entertainments at which we have assisted include the 'Open Day' of the National Physical Laboratory at Teddington (21st May): the London Festival of the Christian Education Movement (21st May): a sixth-form conference on 'Immigration' in Oxford (22nd May): a Jazz Festival in London (30th May): a lecture on 'The Granges of Abingdon and other Abbeys' given by Dr. John Fletcher for the Friends of Abingdon (18th June): and a 'teach-in' on Vietnam at Milham Ford School (20th July).

We took a more active part in a Public Speaking Contest at Culham College (18th May): in a National Quiz, wherein K. G. Robbins, P. J. Wilson and D. G. Hounam, representing the Trinity Methodist Youth Club, won the Southern Region Finals at Stevenage on 29th May: and in the Inter-Schools Dramatic Evening at the Unicorn Theatre (16th July). Members of the School also helped to run the Dr. Barnardo's Fete on 29th May and the Friends of Abingdon Fete on 2nd July.

A kind of 'skeleton' Mock Certificate 'A' level examination was held on 3rd and 4th May, to prepare for the real examinations which began on 5th July. The supplementary School Entrance Examination was held on 1st July.

On 21st July the Prefects defeated the Common Room Eleven in their annual fixture, thanks largely to a fine innings by D. A. M. Bent (80 in half an hour). Later in the same evening they entertained young ladies from four schools, St. Helen's, Didcot, Faringdon and the Abbey School (Reading) to a formal dance in the Court Room, for which Mr. Eric Potter provided the music.

On 19th July Miss Fairlie Winship presented the awards at the Boat Club Regatta. Miss Diana Cobban performed the same office at the Swimming Sports on the 21st. The life-saving examinations followed on the last Monday of term, 26th July.

The events of our new Founder's Day programme are recorded elsewhere. Rain washed out the first day of the Cricket and Tennis matches against the Old Boys, but we were incredibly fortunate to have a dry day on the Saturday, in the teeth of gloomy weather forecasts. Or rather, the rain did not come until the audience was packed into the large marquee for the final performance of the Concert; and we managed to get all the cars out of a very slippery Lower Field afterwards without damage to man or vehicle.

On Monday (26th) the boarders enjoyed their usual end-of-term suppers. Afterwards School House and Crescent did battle on the Waste Court Field, the defeat of the Masters by the Prefects in the tug-of-war being the final set-piece of the programme.

As usual, there has been much holiday activity, both corporate and individual. On the last day of term an all-service contingent of the C.C.F. left for camp near Weymouth, while a small naval party under Mr. Griffin revisited Loch Ewe in Western Ross. The Scouts encamped in Miserden Park in Gloucestershire. Subsequently Mr. Lewis took a party to the Varsities and Public Schools Camp near Lymington. Another party went off to help the Rev. Mark Williams tidy up his churchyard at Little Braxted.

Of individual members of the C.C.F., N. D. Brice was fortunate enough to be offered a flight to Changi (Singapore) and arrived back just before term ended. D. J. Munson and D. W. Penney have been implementing their Flying Scholarships. D. Clare and P. G. Tooze attended cadet 'star' camps at South Cerney and Henlow respectively, M. A. Cockerill a gliding course at Henlow, M. G. Cockman, A. R. Coffee and R. W. Schnellmann a cadet leadership course at Frimley Park. And sometime Warrant Officer Steven Nicholl returned safely from his exciting tour of America under the auspices of the U.S.A.A.F.

The Gryphon Boat Club, sponsored by Mr. Butt, flew their flag in the Maidenhead Regatta on 31st July. Some of our cricketers spent the first few days of the holidays playing in the 'Festival' organised by the newly formed 'Abingdon Alligators' — a club to which we extend a hearty welcome. Later D. A. M. Bent and P. N. Shellard played for the Berkshire Bantams. We have just heard of Bent's century (101 not out) against Hampshire.

Three of our musicians, A. G. Fairlie, P. H. Fletcher, and A. R. Gibbs, again took part in the Drayton Chamber Music Party; and G. H. Hallett and S. P. Sewry attended Mr. Pratt's Chamber Music Course at Keele. Career-wise, T. J. Havelock attended a course with Ericsson Telephone and Electric Company. T. Lewis attended a summer school

organised by Rolls-Royce. Of our linguists, P. K. Booker, R. A. Forsythe and M. J. Heading attended vacation courses in French at Strasbourg, P. S. Gilbert an Inter-lingua course in German at Salzburg, and I. R. Hewes, F. R. Howlett, and N. Jotcham courses in Russian at Cambridge.

On Sunday, 1st August, the County Inspection of the St. John Ambulance Brigade was held in Lower Field.



FROM THE HEADMASTER

My visit to Persia has been overlaid by the events of a very busy term, but it would be ungracious of me not to say how grateful I am to all of those who kept the School running so smoothly while I was lecturing to university dons, addressing girls' training colleges, visiting

high schools, haranguing infant classes in remote villages, or just talking to schoolmasters. Our own educational problems are insignificant compared with those that the Persians have to face, and now if ever I feel depressed I think of the Persian schoolmaster coping with a class of seventy sixteen-year-olds, or the young man of the Literary Corps whose first assignment is to persuade the villagers to build him a school-room.

Then at the end of the term came Founder's Day, which for the first time for many years was combined with Old Boys' Day. Despite unfavourable weather conditions it seemed clear that we had now devised a viable programme, and I think we shall follow it very closely in future years. We now look forward to the Prize-Giving which you will remember is to be held on the afternoon of Thursday, 23rd September. With Corn Exchange demolished, Civic Hall not yet completed, we are bound to hold it in our own Court Room. As we want as many boys as possible to hear General Feilden, we regret that we must restrict invitations to the parents of actual prize-winners, all of whom should by now have received a personal card.

The Dayboys' Changing Room is ready for use and I am sure it will prove a tremendous amenity. Recently the Building Committee of the Governors approved the revised plans for the Dining Hall Block and the Ingham Music School — the latter, of course, being sponsored by the Appeal Fund. These plans are now being submitted to the Department and I very much hope that even in these days of restrictions our needs will be so patent that we may receive the necessary approval for both projects. At all events they are in the pipe-line and we can do no more. The fact that the Governors are firmly resolved to push vigorously on with both these projects is a clear indication of the confidence they feel in the future of the School.

There is much activity in the School buildings at the moment. The experts have arrived to fit the handrails to all our unprotected staircases— a much more tricky job than might be expected. Lacies Court is alive with workmen. We are making the minimum of structural alteration, but there is much to do in the way of rewiring and redecoration. We plan during next term to have one of the cubicles in the Big Dormitory of School House turned into a study-bedroom as a model for the Governors to look at; while minor projects which we hope will call for serious consideration before long include the rehabilitation of the Gymnasium, and the construction of two new hard tennis courts.

I shall always cherish my own memories of Mr. Murray and of Mr. Booth. It was not until Mr. Murray had been appointed that I discovered he was the son of an old war-time friend with whom I had lost touch. It didn't take long for his kilt to be accepted as a part of our

landscape. I once had the good fortune to hear Mr. Booth exhorting the Fifteen before a match. I understood then why the team was so successful. I am sure that they — and Mr. Carey and Mr. Foley too — will always feel that they are welcome when they come back to visit us at Abingdon.

I am writing these words with the pen so generously presented to me by members of the House on the last night of the term. It is now almost the eve of my departure from School House, after fifty-five terms, and I can't pretend that I am enjoying the job of dragging up my roots from the soil that has become a part of me, of sorting through the accumulated detritus of eighteen years, all of which brings its own memories to mind. At the same time I am exhilarated at the thought of starting a new life in the gracious surroundings of Lacies Court, and of running the small 'sixth form house' which should enable me to keep my hand in as house-master without making quite as many demands on me as School House was bound to do. It may be indeed that I shall have time not only to do my job properly, but just to sit back and think occasionally. And I have the satisfaction of knowing that I am handing School House over as a going concern to one who, with his wife, is eminently well qualified for such a responsibility. I am sure the House will give to Mr. and Mrs. Tammadge the same loyalty and affection which it has given me for so long.

CHANGES OF STAFF

Schools which attract possibly more than their fair share of good young men must be prepared to see some of them spread their wings. Indeed there would be something wrong if they all of them stayed put. But it is never pleasant to say goodbye, and this year we have had to do so more often than usual. Having lost Mr. Horrex, Mr. Leake and Mr. Williams, we must now bid farewell to Mr. Murray and to Mr. Booth.

In Mr. Murray's five years here he has served the School indefatigably as form-master, as an inspiring teacher of sixth form classics, as an enthusiastic coach of rugger and of cricket. He was the first resident house-tutor of Heylyn's, and somehow he has found time to include the School Shop in his empire. Mr. Booth came to us only in 1962, but in three years he has established himself as an outstanding rugger coach. If you seek his monument, look at the record of last year's first Fifteen. But it is worth adding that he was also a patient and thorough teacher of geography and economics. We shall miss them both enormously (and their ladies too) but we cannot grudge the good fortune of Edinburgh Academy, which now reclaims its own, and the Shawnigan Lake School, British Columbia, which managed to snatch

Mr. Booth from under the nose of several other competing Commonwealth Schools.

Mr. Carey leaves us in order to train to be an architect. In his one year as resident house-tutor he has left a characteristic mark on School House. For Mr. Foley opportunity — the opportunity to return to take over the Mathematics at his old school, S. George's, Harpenden — has knocked far too soon; but in his two terms with us he too has made a highly original contribution. To both of them too, our warm good wishes.

Now for the much more pleasant task of welcoming no less than eight new masters, four scientists, four arts men. Of the scientists, Mr. B. E. Woolnough, B.Sc., secured first-class honours at Reading in Physics and Mathematics before migrating to King's College, Cambridge, for his Dip. Ed. course. He has been teaching Physics at Bedford School for five years, so is well-qualified to take over the duties of Head of the Physics Department - duties which Mr. Blagden has so ably and loyally carried out during the interregnum. Mr. R. V. J. Butt, B.Sc., who graduated in Physics at Edinburgh and then transferred for his diploma course to Fitzwilliam House Cambridge, where he rowed in his College First VIII, is no stranger to us, as he did his student practice here, and revisited the School last term. We have also had the opportunity of seeing something of Mr. C. M. Reynolds, B.A., Major Scholar of Corpus, Cambridge, a young mathematician whose interests range from sailing to swan-upping. Mr. J. M. Truran, B.Sc., another mathematician, graduated at Adelaide and has had teaching experience both in Australia and in England.

Of the arts men, Mr. P. G. Davies, B.A., Open Exhibitioner of St. John's, Oxford, read Classics and English and played in the O.U.R.F.C. trials. He has taught for three years at Queen Elizabeth Grammar School, Wakefield. Mr. A. G. Howard, M.A., who read Modern Languages at Brasenose, has since taught for four years at the Judd School, Tonbridge. More recently he has been seconded for an intensive Russian course in London. His main sporting interests are athletics and cross-country. Mr. Henry Eden, M.A., Choral Exhibitioner of Caius, has been teaching at Felsted Junior School. He is a rugger player who appears regularly for the Harlequins and has been a reserve for the England Team. Lastly, Mr. N. H. Payne, M.A., who read History at Jesus (Cambridge) and also captained his College Eleven. Subsequently, after taking his diploma in Public and Social Administration, he worked for five years as assistant warden of probation hostels.

It will be seen that between them our new-comers have much to contribute to the School. An unusually high proportion of them too have had previous experience of other schools of repute. Cross-fertilisation of ideas is always a good thing. We hope that all of them will find their stay with us both interesting and profitable.

CHAPEL NOTES

The life of the Chapel may be compared to the course of a river. In the main the water keeps its steady flow but broken now and then by turbulent rapids and by gentle calms. So the life of the Chapel is the constant round of Prayer and Sacrament and Worship, and, because this is so, the interruptions of life's sorrows and life's joys are borne along. This term has seen both sadness and joy.

On Sunday, 18th July, a Memorial Service was held in Chapel for John Mark Mobbs, O.A., killed in a motor-racing accident in Malaya. The lesson, from I Corinthians 15, was read by the President of the Old Abingdonian Club and the Headmaster gave a short address. The Chapel was most beautifully decorated for this service by Mrs. Mobbs and her daughter, assisted by Mrs. Potter.

More joyful occasions have been two baptisms. Elizabeth Jill Hasnip was baptised on 29th May and Richard Hugh Roger Mortimer on 20th June.

Ascension Day dawned bright and fine and, following the early celebration, the Choir sang their hymn on the roof of the Science Block. Whit-Sunday coincided with half term, but there was a celebration in Chapel for those who remained behind.

The Choir under the direction of John Cullen have led the singing with vigour, and the new setting of the 23rd Psalm by Fr. Gelineau, with its repeated antiphon, was most attractive. A list of the anthems they have sung is at the bottom of these notes. On Sunday, 20th June, they sang Evensong in Ashbury Parish Church and won very favourable comments. Whilst on the subject of music, we have now reached the position where it is imperative that we renew our hymnbooks. There seem to be various alternatives, and this holidays we shall decide which of the new hymnbooks to have. We are most grateful to those many parents who have already paid for hymnbooks which will be bought in their name and suitably inscribed.

A very cold Saturday afternoon on 29th May saw a visit from a party of parishioners from St. Anne's, Limehouse, with their vicar. In spite of the weather they enjoyed the afternoon, and it was a great pleasure for us to be able to return something of the hospitality which we have enjoyed at their hands. Many of the party joined with us on Saturday evening Compline before returning to Limehouse.

Thirty-one boys are at present attending Confirmation Classes. Confirmation will be administered by the Bishop of Oxford in the Chapel on 5th December. The Society of St. John the Evangelist, better known as The Cowley Fathers, will be running two quiet afternoons for the candidates at their Mission House next term.

The Beginning of Term Service in St. Helen's Church, at which our Preacher was the Rev. F. C. T. Lancaster, Vicar of Drayton, was unusual in that the Headmaster was away in Persia. But perhaps the most memorable Services of the term were the Founder's Day Service at St. Helen's Church, at which our Preacher was the Archdeacon of Oxford, and the Service for Leavers, which took place on the last Sunday evening of term in St. Nicolas' Church.

EXAMINATION RESULTS

Results this year, at each level, give grounds for modest satisfaction. Of course there are individual disappointments, and again there was this curious contrast between on the one hand the poor showing of the Sixth Former in his attempt to capture the odd 'O' level which had eluded him for so long and on the other hand the apparent ease with

which the young Fourth Former sailed through two or three subjects a year in advance. But the total of subject-passes at Advanced Level (227) was almost one fifth more than last year's total, itself a record; and the 686 passes at Ordinary Level represent a substantial increase on any previous figure. What is equally pleasing is the welcome improvement in the number of marks of distinction and merit obtained in the 'Special' papers. The combined total is half as big again as last year. Particularly notable at Advanced Level was the achievement of the English faculty, which amassed thirteen passes at Grades A and B out of twenty candidates, and at Ordinary Level the unbroken run of success obtained by the 31 candidates who took Latin in the fourth forms, and the 64 who took French.

FOUNDER'S DAY


The new State Calendar made this year's end of term weekend something of an experiment. Unfortunately, with the Old Boys' Day being literally washed out, and rain always threatening on Founder's Day itself, it is impossible as yet to obtain a clear picture of the new arrangement. It was, however, something of an achievement to have completed all preparations in the conditions of that week, and we were fortunate indeed in that there was only one brief shower on the Saturday afternoon, and even that was not enough to drive the visitors under shelter. It was not until late in the evening that really heavy rain justified the gloomy prediction of the experts.

The day's programme began with the Morning Service, and once again, even with extra seating, St. Helen's Church was completely full. The preacher this year was the Ven. C. Whitton-Davies, Archdeacon of Oxford, whom many may remember from the Founder's Day of 1960—and to be asked again was an unusual honour, as he duly observed. We can only add that we hope that the Archdeacon will visit us yet again before very long.

The gap in the afternoon's timetable left by the transfer of the Prize Giving to September was largely filled by the various encounters with the Old Boys on the sports field. Many visitors made the journey to the War Memorial Field to watch the First Eleven in action, pausing to see something of the tennis match en route. Meanwhile, for the less adventurous, there was the spectacle of the two second elevens doing battle in front of the School — something that undoubtedly adds a pleasant touch to the day's proceedings.

In the corner of Upper Field, beside a really vast marquee, the Headmaster was 'At Home' to the many parents and friends of the School present. During the course of the tea, the playing of the Band by Tower Steps proved to be a rival attraction to the adjacent cricket match.

For those embarking on a tour of the local places of interest, the Library, the Chapel, the Tuck Shop and the Swimming Pool continued, as in recent years, to attract most attention, as well they might. In addition, the new Changing Rooms, which last year appeared merely as plans and 'artists' impressions' displayed in the Entrance Hall, were there in solid form for all to see, and their place on the drawing boards

was taken by the new Dining Hall. Of the exhibitions, mention must be made of the first rate display in the Glyn Room of the painting and sculpture of local Training College students (designed mainly to show our own boys what can be done), of the folk group playing so enthusiastically in the Gymnasium, of the numerous fascinating experiments being conducted in the laboratories.

The day's activities ended with an Evening Concert, which because of the 'interregnum' following the demise of the Corn Exchange was held in the huge marquee on Upper Field. A critique of this Concert appears below.

Sunday is always something of an anti-climax, being generally spent in recovering from the day before. However, the relaxed atmosphere did prove excellent for the Leavers' Service in the evening, when St. Nicolas' Church was just comfortably filled. The Headmaster's sermon was specifically directed to those about to enter the world of responsibility. He stressed the importance of choice in the world today, and in particular urged each individual to face the challenge of decision in the three vital matters of career, marriage and religion. In the words of the Deuteronomy lesson: "...I have set before you life and death, blessing and cursing: therefore choose life, that both thou and thy seed may live."

THE SUMMER EVENING CONCERT

We are indebted to Mr. W. A. Chislett, parent and well-known music critic, for the following comments:

"This was my first Abingdon School concert and the uppermost thought in my mind at the end was how well it reflected, and with what skill, patience and judgment Mr. Cullen, Mr. Billington and their colleagues implemented, the wise decision of the Headmaster that music should be an integral part of school life.

School concert programmes are often designed to show the exceptional capabilities of a handful of outstanding pupils but here was one chosen to bring to the platform as many boys as possible. Even after allowing for duplications and not counting the few adults who helped, upwards of a quarter of the school took part. Bearing this in mind, the quality was quite remarkably high.

As one concerned intimately with records for many years I appreciate perhaps more than most the unique opportunities they provide for both study and enjoyment. But this does not blind me to the fact that they can also tend to discourage the making of one's own music. And no amount of listening can replace participation in concerted music, on however modest a scale.

There is another aspect of modern records which is disturbing. With recordings made originally on tape it is possible to play and replay short passages until perfection is reached in each and then piece the best bits together as a continuous performance. This, in fact, is how many records are made now and the result can be a performance of technical perfection which is virtually impossible of attainment in a concert hall but which can and sometimes does lack the air of spontaneity and the feeling that those taking part are enjoying playing together which are hall-marks of the finest performances. These highly desirable qualities — indicating good teaching — came through splendidly at the concert on 24th July, and in saying how grateful they were to my ears I speak both as a critic and as the father of a boy who will. I hope, earn his place in the first orchestra in due time.

The programme started with the sparkling Thieving Magpie Overture, in which the exuberance of the percussion players would have delighted Rossini. But, of course, he would have been in a position to demand more strings whereas any school orchestra has to be satisfied with what is available year by year. A similar lack of balance resulted in a somewhat garbled account of Offenbach's Orpheus in the Underworld Overture presented by the Concert Band, which is, I gather, new and is a hybrid founded on the older brass band with a few woodwind instruments added. Being still preponderantly brass and with trumpets in the lead the woodwind had rather a thin time of it. As exercises in the tautening of rhythm both pieces are first class.

In the Purcell Ode we had our first taste of what the First Orchestra could do when properly balanced. For this Mr. Cullen handed the baton to Mr. Billington and went to the harpsichord on which he provided such sensitive support for the excellent team of soloists that I promptly forgave him for what I thought the unduly slow and dragging tempo he had chosen for the first verse of the National Anthem which preceded the programme proper. From the very first bars of the instrumental prelude Anthony Gibbs, the leader of the orchestra, revealed not only playing of fine quality but also the ability really to lead. Whether or not he is contemplating a musical career I do not know but if he is I venture to prophesy a very bright future for him. The orchestra and Choral Society played and sang with a nice sense of style and firm but not over-accented rhythm. The tenors and basses of the chorus had previously displayed similar qualities in a lively drinking song and Mulligan's Musketeers, which, by the way, is much more difficult than it sounds to be.

After the interval the Second Orchestra tackled some music by Schubert in a way that suggested inadequate rehearsal time. They might, I fancy, have found the solider rhythms of the Waltzes which were in the programme but not played easier than the bouncing lilt which the Rosamunde music demands. But to aim high never did anyone any harm and they gave creditable performances of really difficult music.

Five poems were declaimed by a team of twelve boys with admirable feeling for the meaning of the words and in a style that was most pleasantly free from the artificiality that so often spoils verse declamation en masse.

Finally came two performances for which no praise would be too high. In the first not only was Stephen Sewry an efficient, musicianly and self-assured soloist in Strauss's difficult horn concerto but the orchestra supported him with quite remarkable success. In particular I was impressed by the aplomb with which the soloist ignored the odd cracked or false note which is inevitable on the horn. In the second Mr. Donald Hawksworth set a standard as the piano soloist in Constant Lambert's Rio Grande that was difficult to live up to but Mr. Cullen had everyone, choir and orchestra alike, on their toes and the result was a veritable tour de force.

To what extent the experiment of having the concert in a marquee can be regarded as a success I am not really qualified to judge. All I can say is that from the front, where I was sitting, the sound was as clean as one could wish."

CRICKET

FIRST ELEVEN

Wet wickets and a fallible batting side — not the happiest of situations, and this is how 1965 will be remembered here. The loss of Shellard and C. C. Ford was heavily felt and our middle batting hardly ever took advantage of the good start often provided by the first three. Jennings improved much and accepting that he would score slowly, played really well at times. Bent was a tower of strength, though he will never achieve his full potential until he is prepared to "get behind" the fast bowlers. Davis played some good innings but was too often out playing to mid-wicket rather than straight. Henderson made one very good fifty against Solihull, but otherwise disappointed through lack of stroke play. Partridge was perhaps the most improved batsman in the side, though he still does not make full use of his power because he hits across the ball. Jackson somehow never did come off, while Morris had a most miserable season, redeemed a little by his innings against the Dutch boys.

Perhaps the most disappointing aspect was that this has been one of the best bowling and fielding sides for some years. Bent's captaincy and field placing were in general mature and sound and he was backed up by enthusiasm and skill in every department. Pride of place among the bowlers must go to Penney and Heading, both of whom have bowled long and effective spells against experienced players to good effect. Cook had his moments of glory and as a fifteen-year-old bowling fast left arm over the wicket is clearly destined for many more. Brice was unlucky to pull a groin muscle early on, but is a fast bowler/ batsman of unusual promise. T. B. Moore filled his place as an allrounder in later matches. Jackson bowled his off spinners well on occasions but is still too easily overawed by an attacking batsman. When given long spells of bowling in the last two matches he showed that he could be a match winner. Partridge never really had a fair crack of the whip on these soft wickets but when he did bowl he did so with accuracy and confidence. Bent himself proved a valuable change bowler, though at times he was inclined to bowl too much. No wonder then that they were able to contain any opposition, for with such a well balanced attack there was something to deal with every batsman. The only player who was ever really on top was the Headmaster's nephew, Lt.-Cdr. John Dook, playing for Incogniti, and he smote the ball all over the field in a magnificent undefeated century.

As a slip catcher Bent has few equals in schoolboy cricket and Partridge, Penney, Heading and Jackson deserve mention in a side outstanding for its fielding and throwing. This was a great source of pleasure to onlookers and did much to compensate for batting failures. We haven't had a better-looking fielding side since the palmy days of 1962. Henderson as wicket keeper was sounder and contrives to make

the less tidy returns look accurate and must be accounted as good a keeper as we have had in recent years. Ironically, perhaps, his best performance and Moore's, were in a Sunday match when they were supplementing a Common Room XI against strong opposition — six catches, five of them off Moore, who took eight wickets altogether!

There were high spots — our defeat of Solihull, a favourite rival — and low spots — our defeat by Royal Masonic, Bushey. There was much to cheer — Bent's 100 against Southampton — and to disappoint



— losing to M.C.C. in our first fixture with them, after being in a strong position. It has been a happy side, eager to learn to play the game and entering whole heartedly into practice and performance. Half of them will still be here next year and under Penney's captaincy should form the nucleus of a useful team. Given hard wickets — sadly lacking in 1965! — they could redeem their reputations as batsmen, and they should certainly be formidable in attack.

The new score box on War Memorial Field has proved a great boon and even the most short sighted can now tell what the score is.

Of the two cricket photographs in these pages, the one was taken on the occasion of the match against the M.C.C.; the other, which needs no caption, aptly summarises the season.

A new venture this year has been the founding of the Alligators Cricket Club, to play matches on the first four days of the week after the Old Boys' game against the School which has now become a twoday match on the last Friday and Saturday of term. There was such a good response to this among Old Boys, Masters and boys that this is certain to become an annual event. We found ourselves short of runs but there was no lack of good fellowship and we shall do better next year now that the Club is safely launched. Special words of thanks are due to the Headmaster and the Bursar for their ready agreement and active co-operation; to Miss Gray and the kitchen staff who did us proud; and to Gerald Smithson for producing the usual splendid wickets. One of the disappointments was that the latter's injured hand prevented all but a token appearance this year. We are proud to welcome as President of the Club the Headmaster, who managed to find time to

SECOND ELEVEN

Whatever technical failings a Second Eleven may have their matches are usually characterized by a team spirit buoyant enough to ensure a good game, so resilient as to enable the team to carry the unexpected failure of an individual performer.

By comparison with other seasons this spirit was slow to mature this year and there was a lack of purpose and concentration in the earlier matches. Burns realised an ambition and became a competent wicket-keeper, conceding only three byes in his two games. All in all, we again had a useful side, many of whose members will still be at School next year; to the rest we wish every success in Club Cricket.

COLTS ELEVEN

Not surprisingly, the rain made its mark on the season, causing the cancellation of two matches, the re-arrangement of another and the disruption of several practice sessions. The effect on morale was perhaps more serious than the actual physical inconvenience for, in fact, the team completed six of the eight matches on their programme. They defeated Cokethorpe, had the best of a draw with Bloxham, shared the honours with Douai and were well beaten by Radley, Oratory and St. Edward's.

Although results were comparatively indistinguished the team enjoyed its cricket and always showed a high degree of enthusiasm. There was an excellent spirit which ran from the conscientious captain Bradley to the members of the "shadow squad" who just failed to make the eleven. In fact, the pressure from these two extremes was instrumental in creating the right atmosphere within the team itself.

They were primarily a bowling side, always appearing more likely to bowl out the opposition than to make a big score.

Pride of place among the bowlers goes to Nancarrow who bowled 74 overs — twice as many as his nearest rival — to take 17 wickets for 147 runs. He was supported by Cook, who bowled with verve and hostility when he was not called to higher things, Morgan, who developed a fair pace and made considerable improvement over the season and Matthews, who made his mark this season as a very effective leg spinner. Parfitt and Rothwell were in reserve as medium pace change bowlers.

Morgan was the most successful batsman. He was more relaxed this season and played two very good innings. Bradley did well as an opening batsmen and found a useful partner in Osborne during the second half of the season. Parfitt batted well on several occasions. He hit the ball hard, had a good temperament and was a valuable find. Moore, Parry and Paddison had several shots but were not sufficiently powerful to make good scores. Ford was a good attacking batsman but lack of concentration appeared to spoil his defence. Mosdell was an

efficient wicket-keeper and Parry, Parfitt and Moore distinguished themselves by their fielding.

JUNIOR COLTS ELEVEN

The most successful batsman was Sayce D., with innings of 31 (Oratory) 46 (Salesian) and 68 (St. Edward's) the last in particular a fine effort

when he really carried the rest of the side. Other good innings came from Varley A. (21 — Radley, 43 not out — Oratory, including several fine sixes and two lost balls) — a somewhat impetuous batsman this, who when learns concentration should score many runs, Sayce J. (32 v. Salesian), and Rose (36 v. High Wycombe), while Cowley's 21 against Bloxham was invaluable and enabled us to snatch victory when a low score had seemed to make defeat inevitable.

Of the bowlers Varley A. was far and away the most successful, claiming many of his victims by sheer speed and taking a total of 26 wickets for 6 runs apiece. His best performance was 7 for 16 against Bloxham. No other bowler took 10 wickets, Rose taking 8 and Fellows 7.

The fielding was usually adequate though a few catches went down, and some people were lamentably slow both to move to the ball and to throw it in. There was, however, a lack of that zest and alertness which distinguishes the really first class fielding side. PcPhail kept wicket keenly, and quite well, and always looked like a wicketkeeper.

Varley was an exceptionally keen captain who set a high standard in his own play and led his men effectively on the field.

From the angle of weather and results this has been a most disappointing season. No fewer than three matches were cancelled, and all those played were lost.

Despite the bare results however, this year's game has probably contained more individual talent than in many previous seasons, and technical ability improved rapidly. The results were due almost entirely to lack of confidence and match temperament. The bowlers were

particularly prone to bowling shorter and faster than in practice, in the mistaken idea that this would produce wickets, and the batsmen would play shots they would never dream of in the nets. As noteworthy exceptions to this should be mentioned Cox and Comerford for their batting and Deane for his bowling.

Fielding was usually sound, if not spectacular. Hill captained the side keenly, although he might have taken a stronger line in checking his erring bowlers. Both he and Varley (M.) are extremely promising batsmen and should settle down with experience.

Whilst the decision concerning Henley was inevitable, it is good that the crew was judged up to standard for an entry to be considered: one can only sympathise with those members of the crew whose ambition it had always been to row for the School in the Princess Elizabeth Cup.

The 2nd VIII always looked as though they would be the fastest ever. But apart from their first two regattas they never produced the form expected of them. They too suffered reorganisation after Reading, and this no doubt affected them to some extent. It seems that our crews must learn not to be unduly upset by change in future.

The 3rd VIII and the Colts showed much promise, and the various fours which raced at different levels enjoyed themselves even if their progress was not as rapid as we should have liked.

Our new Boat House is approaching completion and has already made life much easier. We look forward to enjoying all its amenities next year. The new clinker eight, ordered three years ago, suddenly arrived, much to the joy of the Colts. Our two old shell sculling boats were damaged beyond repair in an accident in the Boat House. Any offers of replacements would be welcomed!

Finally, grateful thanks are due to our faithful supporters amongst the parents and Old Boys, and also to the Captain and Secretary of Boats who both did a fine job for the Club during the year.





ATHLETICS

The number of full-time athletes has been much smaller this year, and consequently our team has been rather unbalanced. We have been strong in most track events — with Avery outstanding in the 880 and mile — but in the field events only Bosley NAH (Shot) has been consistent although Hassett (Javelin) and Akinbiyi (Long Jump) have performed creditably at times.

A large proportion of the team, with A levels in prospect, were not keen to have many matches in the second half of term but it was unfortunate that a date could not be agreed upon for the triangular match against Stamford and Pocklington, and also that an invitation to compete at Radley had to be declined as it clashed with the Berkshire Schools Championships.

In our first match, against Cokethorpe, we took 1st and 2nd places in every event except three and won 80—43. Corps won the short sprint in 10.3 secs. and Bosley NAH put the Shot 51ft. 4ins. The following week Westminster College proved too good for us and we lost 74—101. Avery scored another double in the 880 and mile but Bosley was our only other winner.

The Berkshire AAA Championships were held at Maidenhead on 29th May in bitterly cold conditions. We did not do as well as in recent years and had to be content with 5 third places and 4 fourths.

The match against Wallingford proved to be just as exciting as last year. The result depended on the last event — the relay. Bosley PV ran an excellent first leg and the others just managed to hold on to the lead which he had given them. The time of 45.5 secs. is a new School Record. In the mile we ran 4 "guests" in addition to our two named runners, and actually took the first four places. Hewes, who was just beaten into 8th place by the Wallingford second string clocked 5:14.

What a pity that he hadn't shown the same confidence in the Under 15 Mile on Sports Day!

At the North Berkshire Schools' Championships at Fitzharrys School, Bosley NAH was awarded the Stan Eldon trophy for the best performance in a Field Event, and 10 others were also selected to represent the District in the County School Championships at Palmer Park on 19th June. As a result of these, Bosley NAH was invited to represent the County at the All England Championships but it was most unfortunate that, after showing himself to be in tremendous form with puts of well over 50ft., he should severely twist his ankle and be unable to compete.

TENNIS

In retrospect the season has been one of promise rather than fulfilment. Only three matches against other schools were lost by the 1st VI and two of these were played away on high bouncing hard courts, where we shall continue to be at a disadvantage until we have hard courts of this type of our own. The wet weather imposed severe limitations on grass court play and many important practices had to be cancelled, though most of the 1st VI match programme was completed.

It was anticipated that matches against strong experienced club sides would be lost, but they provided a great stimulus for raising the standard of play. The new fixture against the Bohemian Club, Oxford, and the Abingdon L.T.C. fixture proved particularly enjoyable and instructive, emphasizing the importance of good finishing volleys and correct positional play. It is recommended that more boys should join a good tennis club for the holidays and when possible fit in some extra club games in the term.

The 1st pair, R. E. N. Bradfield, the Captain, and M. G. Cockman, the Secretary, had a largely successful season and were always exciting to watch. Bradfield has not yet developed a really strong service or good spin service, but his backhand driving and volleying have been of a consistently high order. Cockman proved an excellent partner producing some splendid attacking forehand drives and lethal first services. He needs to overcome his tendency to be caught out of position a few yards inside the base line, though his capacity for extricating himself with a half volley off his toes is remarkable. He must also improve his second service and develop a crisper backhand volley.

Matching up the 2nd and 3rd pairs involved much experiment. The most promising player was P. A. C. Roblin, who was very agile about the court and had a flair for volleying, but unfortunately lacked a reliable and effective service. He was finally partnered in the 2nd pair with R. P. Jessett, who had a strong service and could make good drives and volleys when in position - slowness about the court being his main weakness. The 3rd pair was completed with P. B. Godfrey, a dashing, cheerful, sometimes erratic player; and A. C. Hoddinott, who had all the strokes but often lacked finishing power. In the early trials Orland and Liversidge never produced in match play the form they showed in practice; while Jackson, though full of promise and attacking strokes, was never sufficiently steady. Luttman and Walkinshaw had a very successful partnership in the 2nd VI, but were less impressive when tried in the 1st VI; but it was pleasing to note how much more forceful Luttman's play had become, and he should make his mark next season.

The 2nd VI had a very good season, only losing one match; and as mentioned above, many of its members had some games in the 1st VI. Both the 2nd and Junior VI fixtures suffered from the weather, but the new junior recruits made very good progress; particularly Davis and Cantwell, who formed a strong end of season partnership. Woods produced some very impressive match winning volleying and together with Luff he should form a strong nucleus for building next year's Junior VI. Once again we thank Mr. Lay for all the help he has given to the juniors, particularly to the Thomas Bowl pair mentioned elsewhere, and for his weekly coaching visits.

There were 57 entrants for the Buckley Cup singles championship, showing the great interest taken in tennis outside the regular players.


ARMY SECTION



It is truly grievous to have to record at one time the deaths of three young Old Boys, all as the result of accidents on the road, when they were beginning to make their mark in various spheres.

Michael Dicker was at the School with his brother Clive and had been for some years with the firm of John Dickinson. Last year he was promoted to be the firm's representative in North Wales and it was near his home in Abergele that he received fatal injuries in collision with a motor-coach. He was married three years ago and leaves a widow and four months old daughter.

Peter Mildenhall left School from the Science Sixth Form to become a Student Apprentice in the Research and Development Laboratories at Pressed Steel Co. Cowley. He had completed three years of his apprenticeship and three days after his death news was received that he had passed the Higher National Certificate in Metallurgy. He was a keen member of the Abingdon Squadron A.T.C. and had gained a solo gliding certificate. He sustained injuries, which proved fatal, when his motor cycle collided with a lorry at a danger-spot in Appleford.

John Mobbs was Head of Dayboys during his last year at School, and after a short period in the Army he joined a plantation firm in Malaya. He enjoyed the life there to the full and made quite a name for himself in rallies and racing. It is tragic that his absorbing love of cars and their skilful handing should have caused his untimely death, which occurred in a road race as he tried unselfishly to avoid a fellow competitor.

To the parents and families of these three we extend our deep sympathy in their grievous loss.

As we go to press we hear that Steven Nicholl (1965) has been awarded an R.A.F. University Scholarship, so he will be commissioned as Pilot-Officer before going up to Pembroke in October.

ANNUAL GENERAL MEETING 1965

The Annual General Meeting of the Club was held in the Gymnasium at 6.30 p.m. on Friday, 23rd July, 1965. The President, Mr. Duncan West took the chair, and twenty-six members were present. Apologies were received from H. Insley-Fox, J. M. Iredale, L. P. Mosdell, Sir George Sinclair, and Cmdr. T. T. Theophilus.

- 1. The Minutes of the previous meeting were approved.
- 2. The Secretary reported that as a full year had not elapsed since the last A.G.M., due to changes in the Club's programme, there was less than usual to report. Sixteen new members had been elected to the Club. The Annual Dinner held in November had been a most successful function, as had the London Dinner in March, held once more in the House of Commons.
- 3. The Sports Secretary reported upon a longer period, as there had been no report from him at the previous meeting. Some exciting and close-fought fixtures were reported, including the Club's victory in the 1964 cricket match, with the result being undecided until the last ball of the match. This was the only defeat of the season for the school. The members present were again asked to support the Club in its sporting activities, and to apply to the appropriate Sports Secretary in good time for inclusion in the teams.
- 4. The Treasurer's report gave a statement of accounts as at 31st March, 1965. The main points were —

Income for the year £475 5 11
Excess of income over expenditure £135 11 6
Total assets £1218 17 6

With thanks to the Treasurer and Auditors, the report was adopted. The statement of accounts, and balance sheets are appended in the minute book.

5. Under Any Other Business, these were the main items discussed — The Headmaster commented on the unfortunate weather which had marred the first O.A. Day under the 'Bury System'.

The Secretary of the Appeal Fund reported on the good progress of the Fund, which now stood at £62,000 and very near to the target. The school would continue to be grateful for any further contributions. The President thanked Mr. Hillary for his work in connection with the Appeal, and added his hope that the target would be comfortably exceeded in due course.

Mr. R. E. Eason said that he had a proposition to make, and as it concerned the Headmaster, he asked if the Headmaster would be kind enough to withdraw from the meeting. After eighteen years selfless devotion to the school, the Headmaster was shortly to vacate School House. It was felt that this was the appropriate moment to reassure the Headmaster of the Club's confidence in him, and in the future of the school, by offering a tangible token of the debt owed to him. It was proposed that the Club should make arrangements to have painted the Headmaster's portrait, to be hung in the new dining hall, and that the meeting should appoint a committee to commission an artist, and to arrange to collect the necessary funds from Old Abingdonians. proposal was seconded by W. M. Isbister, and agreed unanimously. A committee was duly elected to arrange the matter, and the names put forward were those of the President, the Secretary, R. E. Eason, J. H. Hooke, S. D. Plummer and S. A. Fabes. The Headmaster was invited to rejoin the meeting, and the President informed him of the resolution which had been passed. The Headmaster thanked the Club for the great honour paid to him, and expressed his very humble gratitude.

Various suggestions were made by members to alter the prices charged for tickets for the Annual Dinner of the Club. After some discussion, it was proposed from the chair, that the whole question should be examined, and any necessary action taken by the Committee. This was agreed by the meeting.

There being no other business, the President thanked the Officers of the Club and the Headmaster, and declared the meeting closed.

O.A. CLUB NOTES

The first Old Boys' Day held under the new system on the Friday preceeding Founder's Day was unfortunately marred by a very wet day. All play in the Cricket and Tennis matches was cancelled, and there were consequently very few Old Boys at the School.

The Annual General Meeting was held at 6.30 p.m. in the Gymnasium and the minutes are appended.

The Annual Dinner which followed, was generally voted a great success, being held in the School Court Room. The younger Old Boys were again well represented, and 108 members and guests sat down to dinner. The President took the chair, and the Club was pleased to welcome the Mayor of Abingdon, Councillor P. Lambert. Several Governors were among the guests.

The President, Duncan West, proposed the health of the School, and announced the resolution passed at the A.G.M. that the Club should commission an artist to paint a portrait of the Headmaster, to be hung in the new Dining Hall. The Headmaster in his reply, expressed his gratitude to the Club and reported upon the present healthy state of the School. The proceedings were brought to a close with some well-chosen words by the Head of Boarders, P. B. Godfrey. Hearty thanks are due to Mrs. Blake and Mrs. Talbot, who at very short notice produced some beautiful flower arrangements for the tables.

Happily, the weather improved on Founders Day, and the Cricket and Tennis Matches were begun. The 1st XI match was drawn, with the School scoring 169 for 7, and the O.A.s 162 for 8. The School 2nd XI played a good game to beat the Club by 4 wickets. All was not lost however, and the O.A. Tennis VI scored a victory over the School by 5 games to 4. Fuller reports of these matches appear elsewhere in this issue.

We give advance notice that the 1st XV Rugger Match will be played on Saturday, 27th November, on Waste Court Field at 2.30 p.m. This will be followed by the Annual Dance in the Guildhall at 8.30 p.m. until midnight. Tickets for the Dance will shortly be obtainable from the Secretary at 20/- each.

The Committee proposes to limit individual subscriptions to a very small amount and hopes that in due course the list of subscribers will contain the names of a very large number of the members.






